


The following petition was presented, "To the Common Council:

Indianapolis: That the Salaries of the officers of this City shall be as follows, viz:

- The annual salary of the Mayor shall be Six hundred dollars
- 2 The annual Salary of the City Clerk shall be Six hundred dollars.
- 3. The annual Salary of the Marshall shall be five hundred dollars
- The annual salary of the Civil Engineer shall be Eight hundred dollars:
- 5. The annual Salary of the Street Commissioner shall be four hundred dollars.
- 6 The annual Salary of the Clerk of the East Market shall be One hundred and seventy five dollars.
- 7 The annual salary of the Clerk of the West Market shall be One hundred & seventy five dollars.
- The annual Salary of the Sexton of the Public Grave Yard shall be Eighty dollars.
- 9. The annual salary of the Deputy Marshal shall be four hundred dollars.
- 10. The Treasurer shall receive five per centum on the first \$10,000 collected upon the duplicate, and 22 per centum on all collections over and above that amount.
- 11 Each Councilman shall receive two dollars for every regular meeting, and one dollar for every special meeting of the Common Council, he may attend.
- Sec. 2. All fees, salaries, or compensation, allowed by this ordinance, or any other hereafter established shall be paid quaterly on first Monday after the first Tuesday of August, November, February & May of each year.
- Sec. 3 This ordinance to be in force from and after its passage.
