

2nd We have examined the bids for making flag Stone crossings on Washington and Meridian Streets, we find that A.F. Richter and Company are the lowest bidders, they propose to build them as follows. the One one on Meridian Street on South Side, South Side Washington at \$125 dollars, the crossing on Washington East Side, Side of Meridian Street at 145 dollars, also one near Wright house at \$140 dollars, we would reccommend that the two former crossings be let to Richter & Company also the latter provided that the cost to the city Shall not exceed one hundred dollars.

On motion the above was concured in and contract was ordered to be given to Richter and Company on the above conditions..

Snd Your Committee examined the petition of A.Scott, and others asking the council to change the width of Spring Street from 25 to 30 feet and find that John L.Heoreth owns a very Small lot on the Corner of Vermont & Spring Streets, and refuses to give five feet of the Side of his lot for the purpose of widening Said Street. Your committee are of the opinion that the aforesaid Heoreth is in no wise interested in widening Such Street, but on the contrary we beleieve it will do him a Serious damage. Your committee therefore are of the opinion that those interested in opening Such Street Should purchase the ground owned by Said Hereth before they Shall be entitled to use for a Street.





Indianapolis January 22d 1859

To the Common Council Gentlemen.

At the last meeting of your honorable body a resolution was passed directing the City attorney to examine the contract between the city and the Central Canal Company, in order to determine which party is liable for the cost of bridges over Said Central Canal. I have examined the records of the City, and the Charter of the Canal Company and cannot find even to an allusion to a contract existing between the aforesaid parties. I have also consulted Some of the oldest inhabitants and it is their opinion that Such a contract never existed the general act of internal improvement of 1836 under which the Canal was originally constructed prescribing certain Specifications, under which private individuals townships cities &c may construct bridges over Canals which would imply that during the time the Canal was held by the State the City was compelled to construct all bridges within her limits the Canal was conveyed by the State together with all her rights, privelages appurtenances &c thereunto belonging or appertaining to private individuals, and Shortly after a company was incorporated by the Legislature under the name and Style of the Central Canal manufacturing water works Company, the Canal has changed hands Several times Since the incorporation of the above Company and is now forfeited to the City for delinquent taxes. So that the question, which party is liable for the cost of the Construction of bridges there being no express contract becomes a very Complicated, and difficult one. The majority of the previous owners of the Canal are non residents, and the Canal is now forfeited to the City. So that it is a question of little moment, which of the
