Which motion did not prevail.


- \* Mr. Maguire offered the following ordinance for adoption:
   "An ordinance explanatory of an ordinance amendatory of an ordinance, entitled an ordinance to prevent the erection of Wooden buildings on Washington Street."
- Sec 1. Be it ordained by the Common of the city of Indianapolis, That the ordinance amendatory of an ordinance entitled "an ordinance to prevent the errection of Wooden buildings on Washington street approved September 5th 1853, be so construed as not to interfere with the erection of buildings for which contracts has been made and materials furnished on the ground previous to the passage of said ordinance.

Section 2. This ordinance to be in force from and after its passage.

"An ordinance relative to the levying of taxes for the year 1853 for city purposes.



Section 1. Be it ordained by the Common Council of the city of Indianapolis, That a tax for general city purposes shall be & is hereby levied upon each one hundred dollars, of the value of all property entered for taxation in the general list of city taxables, for the year 1853. The sum of forty cents; and on each poll, subject by law to taxation 50 cents.

Sec 2. That there is hereby levied, upon each one hundred dollars of said list of Taxables, for school purposes for the current year the sum of twenty cents.

Sec 3. This ordinance to be in force from and after its passage.

Mr. Newcomb moved the blank relative to poll tax be filled by the figures 25

Mr. Edwards that it be filled with figures 50.

The question being "Shall the blank be filled with the fifures 50?"

It was decided in the affirmative.

On Motion by Mr.

"Section 1st was amended by adding" and on each day on the assessment roll one dollar".

Which Motion prevailed.

Mr Delzell moved to strike out the word "forty" where it occurs in the ordinance relative to the general city tax, and insert "thirty."

Mr Bradshaw presented an ordinance entitled "An ordinance to prevent the sale and use of spirituous liquors, wine, ale, beer, and other malt liquors with the limits of the city of Indianapolis"

Whereas, this Council has elected a printer /which is not a fact to do their printing, and publish all matters ordered by the Council; And whereas, The City Clerk has seen proper to give a large portion of the printing to other offices contrary to the instructions of this Council; Therefore, be it Resolved That hereafter this Council will not be responsible for the printing contracted for by the city officers with any other than the regularly elected printer, unless directed especially by this Council.
