The Civil Engineer has examined the maps, Laws and Reports in referance to Said Street, and it appears from Such examinations that the Act of the General Assembly of the State of Indiania of 1822 prescribes the width of the Fort Wayne Road to be 48 Feet; A Subsequent Act of the Legislature, making an appropriation and appointing James Blake and William Conner as Commissioners to locate and open a State Road from Indianapolis to Fort Wayne, Said Commissioners Submited their report on the 6th of March

1826, in which it is Stated that the Starting Point of the Fort Wayne Road commenced at the Centre of Indianapolis, thence running East on Market 7½ chains to Pennsylvania Street, thence North 41¼ Chains on Pennsylvania Street to the North end thereof, and thence North 35° 15 East 31½ chains to the first mile post, but no illusion is made to the width of the Road, either within or beyond the limits of the City. An Act of the General Assembly of 1830-31 authorizes the agent of the town of Indianapolis to make a map and Subdivision of the lands donated by the General Government to the State of Indiania, and Bethnel F.Morris was employed by Said agent to make Said map, which made in the year 1831 and the presumption is, that Said map Superseded all the former acts respecting that part of the Fort Wayne Road lying within the limits of the City of Indianapolis, but Said map all though extremely correct and explicit omits to give the width of Fort Wayne Street through out lot thirty Eight, either figuratively or explanatory, and merely exhibits Said Fort Wayne Street by two dotted lines running diagonaly

across the Out Lot. In out Lot no 4 adjoining North Street the map gives the length of the four Sides thereof which leaves 55 feet for Fort Wayne Street; and from St. Clair Street to the donation line, the explanations on the map clearly determines the width of Fort Wayne Street to be 80 feet, but the width through Out Lot 38 is uncertain, as the dotted lines Show the Street Somewhat wider than that through out Lot no 4, and not So wide as that from StClair Street to the donation Line. There is a recorded plat of Subdivision of the North West part of Out Lot No 38 made by Johnathan Owens in the year year 1856 which Specifies the width of Fort Wayne Street to be 80 feet, but upun examination of Mr. Browns Deed to Jonathan Owen's, no illusion is made to the width of Fort Wayne Street, and from the circumstance, the Civil Engineer is of opinion that the insertions of 80 Feet is in-correct, and that it cannot be legally enforced against Mr. Brown. From all these and other considerations, the Civil Engineer cannot determine the width of Fort Wayne Street, between Deleware and Alabama Streets, but if it be the opinion of the Council that an established width Should be made, it may be advisible to appoint a Select committee, together with the Civil Engineer to report to a Subsequent meeting of the Council what in their opinion Should be the width of Said Fort Wayne Street. As the width of the Street on the South Side of Said Out Lot 38 requires to be determined, Said Special Committee, with the Civil Engineer may report upun this Street also. When the Commissioners appointed by the Court to divide the property of the late Mr. Frazee among his heirs they donated 25 feet of ground of the North Side of out Lot No 3 to form a Street.
