Resolved, That the City Engineer be directed to advertize for new proposals to erect or repair a Bridge across Pogues Run on Meridian Street.



Mr. Delzell presented the following communication:
To the Honorable City Council of the City of Indianapolis:
Gentlemen:

The undersigned on behalf of Invincible Fire Company, would most respectfully beg leave to make the following statement of facts viz: On taking our Engine to the fire on the morning of the 11th, it was discovered that she was froze up and we were consequently thrown out of service for nearly one hour and it was all owing to our not being able to keep our Engine House warm. We would most respectfully therefore petition your Honorable Body to have the House we are in at present repaired in such a manner, and under the direction of the Chief Fire Engineer, as to render us comforable and ensure us, after making good time to fires to be able to do some little good with our Engine. We would also state that we have no stove only an old one that we borrowed from a neighbor and would ask that one be bought for us. We sincerely hope that your Honorable Body will take speedy action on our Petition.

I dont beg this of you, I only ask it as justice. I refer you to Mr. Karns for an explanation.

Mr.President:

The select committee to which was referred a resolution of the Council in regard to the selection of a place for the location of the Town Clock, respectfully report that they have had tendered to them for the use of the City the Cupolas of the following buildings, viz: The First Presbyterian Meeting



House, Roberts Chapel, the Baptist Meeting House, and the Union Depot. The conditions upon which the Cupolas of the Churches are tendered are that the City shall be at the expense of fitting them up so as to adapt them to the purpose of accommodating the clock, and keeping it wound up and in repair; in other words the City to have the use of the Cupolas as they are without any charge to the churches. No understanding has been had in relation to the Union Depot because the committee could find no one authorized to make a contract

The committee are of the opinion that the Union Depot. is not sufficiently central as a location for a Town Clock. and therefore would not recommend its adoption unless it were the only place that could be obtained. Either of the three churches before named would, in the opinion of the committee, answer as a temporary location for the Clock and the committee prefer not in their report to give any preference of one over another. The committee are assured that the bells already in the Cupolas of the churches can be made available for the use of the clock, and thus save the expense of purchasing a bell for that purpose. The committee recommend the selection by the Council of one of these churches for the present location of the Clock. The Council are all well acquaited with the location and relative advantages of the several points as a proper place for the public accommodation. The committee are assured by the gentleman by whom the Clock was constructed that so soon as a location shall be made by the Council, he will immediately make preparations for putting it up.

The committee would further repot, that Mr. Bates is utterly opposed to any further negotiation in regard to

placing the clock on his House

a large property-holder in that district, who did not afford as much ground to hope that the property holders will voluntarily pay the amounts assessed against them for the improvement of the side-walk. The committee had no opportunity to see any others of the citizens interested, but will take an early opportunity to do so. At present the committee recommend the following resolution:

Resolved, That the Civil Engineer be directed to proceed, as soon as convenient, to ascertain the amount of work done by Mr. Shea the contractor (leaving out of the estimate the work done by others) and that he report to the Council the value of the work done by the contractor at the contract

price."

The committee ask further time to report on so much of the resolution as relates to a compromise with the property-holders.
