The minutes of the preceeding meeting read and approved.

The Treasurer made Monthly report, referred to the Mayor and Clerk for examination.

The following report was read:
"To the Common Council of Indianapolis:

The undersigned have this day visited the public cisterns in the city, and find them in good order, and well supplied with water.

To the City Council:

Having heard frequent reports (Since the late fire adjoining P. Sponables in regard to the cistern near Mr. Lynch's School room, I would beg leave to make the following report:

The aforesaid cistern up to the time the old Council Chamber was on fire was in good order, after that occurrence, I then had the same refilled. After the fire adjoining Mr. Sponables, I went with Mr. William Wood, and found two feet of water in the cistern.


Mr. Wood went down into the cistern, and found two breaks in the plastering within four feet of the top of the cistern which caused the leak. The plastering was repaired and the cistern filled with water and is now in good order.

The Civil Engineer made the following report:

The undersigned repectfully reports to the Common Council that Mr. Owen Cullings has declined taking the contract for building the bridge over Pogues Run, on Market Street, upon the terms prescribed by your honorable body at your last Meeting, but stated that he would build the bridge for the sum of "One Hundred and Ten Dollars cash" or one hundred & twenty five dollars in city orders, as specified in his proposal.

The Council will please direct what is to be done in this matter.



On Motion, by Mr. Karns, the Engineer was ordered, to contract for said bridge at the \$110 cash.

The undersigned respectfully asks the advice of the Council in regard to drawing contracts for Street and sidewalk improvements, as he feels considerable uncertainty as to what the law is on the subject, whether it be the Common Council, or the propertyholders, or both, that should subscribe such contract as the contracting party of the second part. It appears to the undersigned, that the charter does not define this important particular, or is not explicit on the subject, the Council will therefore please instruct him in the matter, or pass an order for the City Attorney to draw up a legal form of contract for present and future use


The Civil Engineer reported the estimate, Specification & bid for improvement of Vermont Street, between Mississippi street and the canal.

Mr. Carlisle, from the Committee on the Fire Department


made the following report:

The committee on the fire department to whom was the resolution directing the City Clerk to procure suction hose for the Invincible Fire Company, respectfully report that they have examined into the whole matter, and herewith return said resolution, and ask that it be adopted.

Mr. Karns presented the following petition: To the members of the Common Council of Indianapolis: The undersigned would respectfully represent that their petition last year for filling hole made by your order, and grading Vermont street, between Pennsylvania and Meridian street, was not carried into effect, though ordered by your Board, as they understood.



We would respectfully urge the necessity of immediate attention to this rule, being an obstruction to the street, and cangerous, and besides a nuisance in warm weather from standing water. We, then expressed, and now repeat it, that we will pay the proportions falling to us of the expense, according to rules of street grading.

On Motion by Mr. Karns, it was Ordered, That the Civil Engineer be directed to advertise for bids for the improvement of Vermont street, between Pennsylvania & Meridian Streets.

The following petition was presented and read:

To the Honorable, the Common Council of Indianapolis:
The undersigned would respectfully petition your honorable body the street laid out in a circular form beginning at or near the intersection of Meridian Street with Louisiana street, and running from thence in a curved line in the direction of the Madison Depot through Block No. 97. This street was originally laid out with a view of having convenient access to said Depot from the Steam Mill of the proprietors of the ground. Since then a right of way for a railroad track has been obtained along said street and the track constructed, and a number of other tracks have been constructed into the Union Depot, upon which locomotives are necessarily standing during a large portion of the day, blocking up the North end of said street, and rendering it entirely useless for ordinary use.

The undersigned would also respectfully ask that the alleys in said Block No. 97 be vacated, as they were laid out by the proprietors before the construction of the Union track, which track has been so located as to render one of them unsuitable. There has been also permanent improvements made rendering the use of the two others impossible. These alleys have never been thrown open to the public use, and the desire now is to have them vacated, so as to make others suitable to the permanent improvement now made on said Block.

The undersigned is the administrator of the estate of A.W. Morris to which estate said Block belongs.

Mr. Delzell from a select committee on that subject reported adverse to the purchase of any lot, and recommended the leasing of Sibord property for the use of the Invincible Fire Company No. 2,

The Select Committee to whom was referred the matter of procuring a lot on which to erect an engine house for Invincible Fire Company No. 2, were authorized to procure a lease for ground of Sibold at the rate of rent per year as proposed, and, also, with the express stipulation that said Sibold will at the expiration of twenty years pay for any and all improvements made on said lot at their appraised value, or sell the lot at its appraised value

On Motion, Mr. Delzell was granted leave of absence.

Mr. Nelson offered for adoption the following resolution:
Resolved, That the City Attorney be and he is hereby
Girected to institute a suit against Levi Comegys and Joseph
McCord, for the recovery of the possession of lot No. 4, in
the subdivision of lots numbered 1, 2, & 3. in square 57, in
the city of Indianapolis, as subdivided by John Siter agent
for Liber, Price & Co. at the ensuing term of the Marion Circuit court.

Maguire, Nelson, Pitts, & Strickland - 9.


Mr Pitts offered for adoption the following resolution:

Mr Dunlap moved that the Civil Engineer's estimate of the cost of improvement of Bluffroad "hole" be taken from the table.

Which Motion prevailed.

On Motion by Mr. Dunlap it was Ordered, That the Civil Engineer be directed to advertise for bids for said improvement.

On Motion by Mr. Durham it was Ordered, That the Civil Engineer be directed to furnish estimates of the labor performed by Mr Huntington on Ohio Street, & on New. jersey Street sidewalk, between Ohio & New York streets.

On Motion by Mr Nelson,
The resolution suspending the ordinance relative to
Sealer of Weights and Measures was extended till next meeting.

Mr Pitts offered the following resolution for adoption:
"Resolved, That the Marshall be required to immediately
notify the Lafayette Railroad Company to grade North street
between all their tracks that cross North street, and plank
between the rails of their several tracks."

Which was adopted by the following vote:
Ayes: Messrs. Bradshaw, Carlisle, Dunlap, Durham, Karns,
Maguire, Nelson, Pitts, Strickland & Wingate. 10
Noes: None.

On Motion by Mr Pitts it was Ordered, That the Civil Engineer be directed to ascertain whether the Lafayette Railroad Company's track is higher at the crossing of Market street than the ordinance allows, which permits said Company to lay their track in said city.

The subject of the Meridian street improvement was discussed, but nothing done.

Mr Karns presented a petition of L. D. Wilson praying the Council to order the collection of a sum of money due him, upon Engineers estimate, of labor performed on East sidewalk of Pennsylvania street, between Washington street, and Michigan street, by property holders.

On Motion
Referred to Judiciary Committee.

Mr. Carlisle presented the following petition:

To the Common Council of Indianapolis

I have done fifty dollars worth of work on Market Street for, Carroll, on his contract, which I have not been paid for and no prospect of getting it unless your honorable body should direct it to be paid out of the estimate given him by the Engineer, as there is plenty left on the estimate to pay it.
