An ordinance to provide for the lighting a portion of Washington street with gas.

Whereas, The owners of real estate fronting on the South side of Washington Street between Illinois and Tennessee Streets in the City of Indianapolis have petitioned this Council to provide for lighting that part of said city with gas in accordance with the provisions of an ordinance approved November 10th, 1851.

Section 1st Be it ordained by the Common Council of Indianapolis, That there shall be erected under the supervision of the Civil Engineer three lamp posts on the South side of Washington Street fronting Block No. 67 sixty seven, with the necessary lamps and fixtures. And that for the purpose of defraying the expenses of furnishing said lamps and posts, providing their necessary apparatus, and lighting, extinguishing, and cleaning four lamps. (one being already erected) furnishing gas and repairing said posts and lamps for one year from the passage of this ordinance there is hereby levied a tax of fifty cents on each lineal foot of real estate of said Block No. (67) Sixty Seven, fronting on Washington Street, making in all one Hundred and Seventy Eight dollars. (\$178) that being the estimate of the Civil Engineer for the purpose aforesaid.

Sec. 2. Said tax shall be collected in accordance with the provisions of the ordinance entitled "an ordinance in relation to lighting the city" approved November 10th, 1854.

Sec. 3. This ordinance to be in force from and after its passage.

On Motion the rules were suspended, the ordinance read a first, second & third time and adopted by the following vote. Ayes: Messrs. Bradshaw, Carlisle, Dunlap, Delzell, Durham, Edwards, Karns, Maguire, McCarty, Nelson, Newcomb, Pitts, & Strickland - 13.

An ordinance to provide for the lighting a portion of Washington Street with gas.

Whereas, The owners of real estate fronting on the North side of Washington Street, between Illinois and Tennessee streets, in the city of Indianapolis have petitioned this Council to provide for lighting that part of said city with gas in accordance with the provisions of an ordinance approved November, 10, 1854. Therefore

Section 1st Be it ordained by the Common Council of

Indianapolis, That there shall be erected under the superintendence of the Civil Engineer, three lamp posts on the North side of Washington street, between Illinois and Tennessee streets, with the necessary lamps and fixtures. And that for the purpose of defraying the expense of furnishing said posts and lamps, providing their necessary apparatus, and of lighting, extinguishing, and cleaning the lamps, furnishing gas, and repairing said posts and lamps for one year from the passage of this ordinance there is levied a tax of thirty eight cents and two and one half mills on each lineal foot of real estate fronting on Washington street between the points aforesaid, making in all the sum of One Hundred and fifty four (\$154) that being the estimate of the Civil Engineer for the purposes aforesaid.

Sec. 2. Said tax shall be collected in accordance with the provisions of the ordinance in relation to lighting the city, " approved November 10th 1851.

Sec 3. To be in force from and after its passage.

And if not practicable, to so extend said streets to report at what other points through said grounds one or more streets can be constructed North & South through said grounds, and what damage would result therefrom, if any. Mr. Maguire presented the following resolution.

<u>Resolved</u>, That the Civil Engineer be requested to make an estimate of the cost of extending the culvert at the crossing of point where "Illinois street crosses Washington Street to the curbstone on each side of Washington Street, and, also, to report whether the culvert can be improved so as to admit a freer passage of the water.

Mr McCarty moved that the matter of filling up of Bluff road South of Merrill street be taken from the table which Motion did not prevail.

Messrs. Smith & Davis petitioned for the assessment of a yearly tax on for Washington Hall.

Mr. Carlisle presented the following resolution:

Mr. Carlisle presented the following resolution: Resolved, That the cistern near the Carlisle Home be built as soon as possible, as the water is to be taken out of the canal in this month, May, and no wells or water near to save property, in the east part of the fourth or fifth ward could be found to save property.

On Motion by Mr Karns, Laid on the table.

On Motion, Said located cistern was directed to be added to Civil Engineers list.

Mr Dunlap offered the following resolution:

<u>Resolved</u>, That the Mayor be authorized to offer a reward of fifty dollars for the detection and conviction of the person or persons who have been instrumental in setting fire to either dwellings stables, or out houses in the city.

Which was adopted by the following vote: Ayes: Messrs Bradshaw, Dunlap, Durham, Edwards, Karns, Maguire, McCarty, Nelson, Newcomb, & Wingate. Noes: Messrs Pitts & Strickland.

Mr Dunlap presented the following:
