

Mr Karns offered a resolution to permit Mr. Comegys & McCord to occupy the City Lot in Sq 37 until 1st October next by paying such rent as the Committee on Finance shall deem reasonable.

Mr Pitts moved to amend by adding provided they pay rent from the time they have had possession of the property against the will of the City

Which motion prevailed, And the following resolution

Resolved, That Messrs McCord and Comegys be permitted to occupy the lot upon which they have their plank yard (the right to the possession of which the City has recently obtained) until October next, they paying such rent as the Committee on Finance shall deem reasonable, provided; they pay rent from the time they have had possession of the property against the will of the City.
