Sec 3. The ^Ordinance shall take effect and be in force from and after its publication



As it respects the enclosed certificate which was submitted to me at the last meeting of the Council, I have only to say, that sale appears to have been made on the 20th day of Jany 1847, that unless the owner of the property paid or Ceposited the amount of the purchase money, with the delinquent taxes paid by the purchaser and the per sentum therein due, within three years from the day of sale thereof, it is the duty of the Mayor to make a deed, under the seal of the City, to the purchaser or his assigns on production of the certificate. So far as the making of the deed is concerned the loss of the records makes no difference. It may not be improper for me to state, that Mr Langsdale, the purchaser, says that the owner has the Treasurers receipt for the



taxes for the same year for which the lot was sold. If that is true the lot was sold under a mistake and Mr Langsdale would be entitled to have his money refunded. This, however, is a matter about which I know nothing Respectfully Submitted N B Taylor City Attorney
