REPORTS FROM STANDING COMMITTEES.

To the President and Members of the Common Council:

GENTLEMEN: Your Committee on Public Safety and Comfort, to which was referred General Ordinance No. 4, 1906, entitled, "An ordinance regulating and requiring licenses for dances in the City of Indianapolis, suppressing public dance halls and prohibiting the sale or distribution of any intoxicating liquors in any public hall where dancing is conducted," has had said ordinance under consideration, and respectfully recommends that it be amended as follows:

(1) By striking out all of Section 3 of said ordinance.

(2) By changing Section 4 of said ordinance to Section 3.

(3) By changing Section 5 of said ordinance to Section 4.

(4) By changing Section 6 of said ordinance to Section 5.

(5) By amending the title of said ordinance by inserting the word "and" after the word "Indianapolis" in the second line of said title; and by striking out all of said title after the words "dance halls."

seven hundred twenty dollars (\$720.00) per annum. SEC. 5. Department of Public works. Strike out the following words: The night watchman for City Hall shall receive a salary at the rate of fifty dollars (\$50.00) per month.
