DEPARTMENT OF FINANCE, CITY OF INDIANAPOLIS. Indianapolis, Ind., May 21, 1906.

To the President and Members of the Common Council:

GENTLEMEN: I herewith submit a communication from the Department

of Public Health and Charities.

On examination I find that the appropriation for fuel at the City Hospital for the year 1905 was \$8,000.00, of which sum \$7,987.64 was expended, adding to this sum the amount of the 1905 fuel bill unprovided for, \$1,530.73, makes a total cost of fuel for 1905 of \$9,518.37. The appropriation for the year 1906 is \$6,000.00, which sum compared with the 1905 figures is insufficient to meet the demands.

I have prepared and recommend the passage of an ordinance appropriat-

ing the additional sum of \$4,000.00 for such fuel fund.

DEAR SIR: I have been requested by the Board of Health to ask that you get a special appropriation to pay for the outstanding coal bills of the City Hospital and also to carry us to the end of the year. This fund has been exhausted because of the coal bill left us by the previous administration which amounted to \$1,530.73 and also on account of the poor condition of the boilers which requires double the quantity of coal that is necessary.

Owing to the strike, we have been compelled to pay \$3.98 per ton as against \$2.25 when we came into office. We have not, as yet, succeeded in

getting a lower bid on coal.

Dr. Jobes, Superintendent of the City Hospital, estimates that it will require about \$5,000.00 to pay the outstanding bills and carry us to the end of the year.

Kindly recommend this appropriation, at your earliest convenience.
