SIXTH SESSION-APRIL 6, 1885.

The Common Council and Board of Aldermen of the City of Indianapolis convened in sixth Joint Convention, in the Council Chamber, Monday evening, April 6th, 1885, at half-past eight o'clock, pursuant to the following call:

Indianapolis, Ind., April 6th, 1885.

I hereby call the Joint Convention of the Common Council and Board of Aldermen to meet in the Council Chamber on Monday evening, April 6th, 1885, at 8:30 o'clock, for the purpose of electing two Belt Railroad Directors.

President Rorison in the Chair, directed the Secretary to call the roll.

The roll of the members of the Board of Aldermen and Common Council having been called, the following members of the Joint Convention were found to be present:

Alderman Bernhamer placed in nomination James Renihan.

Councilman Rees placed in nomination John Caven. sig. 17. [157]

A ballot was then had, which resulted as follows:

William Harper Morrison received 22 votes.

John M. Kitchen received 25 votes.

James Renihan received 9 votes.

John Caven received 6 votes.

Messrs. Morrison and Kitchen having thus received a majority of all the votes cast, they were declared by the President duly elected Directors of the Belt Railroad.

To the Mayor, Common Council, and Board of Aldermen of the City of Indianapolis

Gentlemen:—I hereby accept the position of Architect of the City of Indianapoli for the preparation of plans, drawings and specifications for a Market House to b crected on the East Market Square, and a building across the west end thereof fo

market purposes, and containing certain offices connected therewith, and an Assembly Hall, under the provisions of an ordinance of said city, entitled "An ordinance providing for the erection of a Market House and Public Buildings, on the ground known as the East Market Square, in the City of Indianapolis," ordained March 9th, 1885.

For the services to be performed by me, the City of Indianapolis is to pay me the sum of four thousand dollars (\$4,000), as provided in said ordinance, for buildings to cost \$150,000, which is equal to two and two-thirds ($2\frac{2}{3}$) per cent on said cost. Should the expense of the buildings be more or less than the said sum of \$150,000, the amount to be paid shall be at the rate of $2\frac{2}{3}$ per centum on such cost.

The payments shall be made as follows: One and one-third $(1\frac{1}{3})$ per cent, shall be paid when the contracts for the construction of said buildings are let, and the other one and one-third $(1\frac{1}{3})$ per cent, shall be paid as the work of constructing said build-

ings progresses and is finished.

And I hereby contract with said City of Indianapolis, in consideration of said compensation to be paid me, to prepare all the proper and necessary plans, drawings and specifications for the construction of the buildings described in said ordinance, and to superintend the construction of said buildings, and to faithfully and henestly discharge all said duties, and any and all other duties imposed upon me as such Architect, by the ordinances of the city in connection with the construction of said buildings. Said ordinance of March 9th, 1885, is hereby made a part of this contract, as fully as if the same was written out at full length herein.

weather. I am of the opinion that if the Street Commissioner would raise the depressions in the walks, according to stakes that I will set, that the trouble complained of will be obviated.

GEO. T. BREUNIG, Esq., City Clerk, Indianapolis, Ind:

Dear Sir:—I have yours of the 19th, and am pleased to get it, as it gives me an opportunity to answer officially what I have been asked so many times by individuals. At the time the ordinance in question was passed, we expected to commence the erection of the shops at once, but our company at that time was visited by a great calamity in the way of successive floods, and before we had fairly recovered from these, the depression in business had become so severe that no Railway manager was justified in undertaking new work. If business shall continue to improve this summer, and next August shall show fair crops along our lines in your State, we shall commence work on our new shops during the coming fall. If the reverse should be true, we shall have to postpone until the times will justify. I believe that the discomfort of the citizens from the vacation of the streets referred to, has been overrated, and that the chief complaint comes from speculators in real estate who have not reaped the profits they expected. However that may be, our intentions are as above set forth. If your honorable body, however, should conclude that the interests of the city demands the opening of the streets in question, we of course shall have to submit and seek another location for our shops. I can not conceive, however, that this can happen, for I believe that the interests of the city and of our company are identical.

The City Attorney submitted the following report; which was received:

To the Common Council and Board of Aldermen:

Gentlemen:—Since the last regular meeting of the Council, the case of Thomas E. Johnson vs. The City et al., to enjoin the payment of the outstanding Sellers Farm bonds, has been dismissed by the plaintiff at his own costs. An act has been passed and approved legalizing the purchase.

In the case of the Connecticut Mutual Life Insurance Company vs. John D. Condit et al., the city being a party on account of the \$250.00 street opening assessment against Mr. Condit's lot for the opening of Fifth street, the plaintiff has dismissed as to the city, at its own costs, leaving said lien to be disposed of hereafter.

I have collected and turned into the treasury, the sum of \$331.20 from the Receiver of the Indiana Banking Company, on the judgment taken by the city against the stockholders of that company for money which ex-Mayor Grubbs had on deposit there at the time of the suspension.

The case of Frank M. Wright vs. The City, asking damages for personal injuries, has been tried since the last meeting. A special verdict was rendered by the jury, in which the facts were rather strongly found against the city. If the court should sustain the findings, the amount of the recovery was fixed at \$2,750.00 A motion for a new trial has been filed and argued, and at the request of plaintiff's attorney, it will be again orally argued before a ruling is made, after which I can more definitely state the situation of the parties, and the probable future results.

REPORTS, ETC., FROM STANDING COMMITTEES.

The Committee on Judiciary, through Councilman Newcomb, submitted the following report:

To the Mayor and Common Council:

Gentlemen:—Your Judiciary Committee and City Attorney, to whom were referred various petitions, beg leave to submit the report thereon:

1st. Is the petition of Harry J. Thrush, asking to be released from the payment of one-half of a certain assessment made against a lot now owned by him, for the opening of an alley in Out-lot 100. A similar petition of a lot owner on this alley, was made and granted about a year ago, and no reason was given in the petition or report of the committees therefor. We do not feel justified, therefore, in accepting that case as a precedent; and knowing no reason why the compromise should be made in this case by accepting less than the original assessment, we recommend that the prayer of the petition be not granted.

2d. The claim of Mrs. Jacob Wagoner, for refunding of taxes, is too stale, the alleged error occurring thirteen years ago, and we recommend that no part of the

claim be allowed.

3d. The demand of R. M. Cosby, for refunding of taxes paid on Lot 15, in Outlot 100, because there was a School Fund mortgage on the same when the taxes accrued, on which a forfeiture has since occurred, has no merit, as the mere existence of a School Fund mortgage does not exempt property from taxation. We recommend that no part of said taxes be refunded.

4th. We have again carefully considered the petition of Mrs. Harriet Keller, presented to the Council December 15, 1884. Our conclusion upon the merits of the controversy, is the same as that expressed in our report of February 2; but we find that the lot of Mrs. Keller is but 130 feet long, instead of 140, as certified by the Engineer; and therefore recommend that the Engineer make the proper deduction to Mrs. Keller, on account of this error, and that the cost of this 10 extra feet (which appears from the plat to be an alley), be paid by the city—the amount to be certified by the Engineer to the City Clerk for insertion in the next appropriation ordinance in the name of the contractors.

5th. The claim of S. W. Patterson, for \$230.00, presented December 15th, 1884, has been carefully investigated by us. The statements of Mr. Patterson and John A. Henry, Esq., who was the City Attorney at the time the judgment was taken against the petitioner on the old Garfield Park lease, are diametrically opposed to each other. We are inclined to give full credit to both gentlemen, and to believe that simply the recollection of one or the other is at fault. But outside of the verbal statements of witnesses, we find that the former Council offset the judgment in question against a like sum to Mr. Pattersen on work done for the city. Mr. Patterson then sued the city for the money now claimed in the petition under consideration, and was beaten. We feel it our duty, therefore, to report against the allowance of this claim.

We present herewith Mr. Henry's written statement of the facts attending the taking of the judgment, to be filed by the Clerk with this report, without printing.

6th. We recommend that the proposition of Wm. S. Hubbard, presented February 2d, to pay \$400 as a full settlement of the Fourth street opening assessment, be accepted. We have examined the matter carefully, and believe that the ground taken from Mr. Hubbard was worth nearly as much as the benefits to the balance of the lot. Beside this, there is little hope of the city ever being able to collect anything by suit; and it is useless to try to get any one to bid at a sale, as past experience proves.

That the Street Commissioner be directed to furnish plank for platform in front of Headquarters Fire Department.

That J. A. Benson have permission to put in a coal vault in front of his property, No. 220 west Washington street.

That the City Civil Engineer be, and is hereby, instructed to prepare a plat of the proposed street west of White River, near the bank of White River.

Councilman Spahr offered the following motion; which was referred to the Chief Fire Engineer and the Special Committee on Fire Department:

That the City Civil Engineer be instructed to locate a cistern of one thousand barrels at the intersection of Clifford avenue and Archer street; and that he be directed to advertise for bids for the same.

Councilman Thalman presented a petition of J. D. Condit, asking for a compromise of assessments of benefits and damages against a part of lot 12, in St. Clair's addition; also petition of Byram & Cornelius, asking for satisfaction of record for an assessment of \$84.00 against lot 5, Fiscus' subdivision of Johnson heirs' addition, for the opening of Rohampton street; and a petition of Jos. Councilman Trusler presented a petition looking to the relief of residents and property owners on Linden street, between Orange and Prospect streets, owing to a defective sidewalk; which was referred to the Committee on Streets and Alleys.

That C. F. Schmidt be, and is hereby, granted permission to grade, bowlder and curb the west side of High street, and pave with brick the sidewalk thereof, from McCarty street to Wyoming street, at their own expense, under the direction of the City Civil Engineer.

That Herman C. Holle be, and is hereby, granted permission to pave with brick the sidewalk in front of his property on Dunlap street, at his own expense, under the direction of the City Civil Engineer.

That Caspar Hess be, and is hereby, granted permission to grade, curb and bowlder the gutter in front of his property on Madison avenue, at his own expense, under the direction of the City Civil Engineer.

Councilman Wolf presented a petition of Hannah Oliver, asking for a refunding of taxes to the amount of \$15.07, with interest, on lots 12 and 13, in Foot's addition; which was referred to the Judiciary Committee.

On motion, the Common Council then adjourned.

SPECIAL SESSION—APRIL 6, 1885.

The Board of Aldermen of the City of Indianapolis, met in the Aldermanic Chamber, Monday evening, April 6th, A. D. 1885, at half-past seven o'clock, in special session, pursuant to the following call:

Indianapolis, April 6th, 1885.

To the Members of the Board of Aldermen of the City of Indianapolis:

Gentlemen:-You are hereby requested to meet in Special Session this, Monday evening, April 6th, 1885, for the purpose of acting on the proposed contract with D. A. Bohlen for supervising, etc., the City Hall and Market House, and for the transaction of such other business as may come before your body,

The following message was read and received:

To the President and Members of the Board of Aldermen:

Gentlemen:—I submit herewith the following papers for your consideration, favorably passed upon by the Common Council at its session held this evening, April 6th, 1885.

The following contract was read, and the favorable action of the Common Council thereon (see pages 160 and 161, ante), was concurred in:

To the Mayor, Common Council, and Board of Aldermen of the City of Indianapolis:

Gentlemen:—I hereby accept the position of Architect of the City of Indianapolis, for the preparation of plans, drawings and specifications for a Market House to be erected on the East Market Square, and a building across the west end thereof for market purposes, and containing certain offices connected therewith, and an Assembly Hall, under the provisions of an ordinance of said city, entitled "An ordinance providing for the erection of a Market House and Public Buildings, on the ground known as the East Market Square, in the City of Indianapolis," ordained March 9th, 1885.

For the services to be performed by me, the City of Indianapolis is to pay me the sum of four thousand dollars (\$4,000), as provided in said ordinance, for buildings to cost \$150,000, which is equal to two and two-thirds (23) per cent. on said cost. Should the expense of the buildings be more or less than the said sum of \$150,000,

the amount to be paid shall be at the rate of $2\frac{3}{3}$ per centum on such cost.

The payments shall be made as follows: One and one-third $(1\frac{1}{3})$ per cent. shall be paid when the contracts for the construction of said buildings are let, and the other one and one-third $(1\frac{1}{3})$ per cent. shall be paid as the work of constructing said buildings progresses and is finished.

And I hereby contract with the City of Indianapolis, in consideration of said compensation to be paid to me, to prepare all the proper and necessary plans, drawings and specifications for the construction of the buildings described in said ordinance, and to superintend the construction of said buildings and to faithfully and honestly discharge all said duties, and any and all other duties imposed upon me as such Architect, by the ordinances of the city in connection with the construction of said buildings. Said ordinance of March 9th, 1885, is hereby made a part of this contract, as fully as if the same was written out at full length herein.

In Witness Whereof, I have hereunto set my hand and seal, this 6th day of D. A. BOHLEN. [Seal.]

The following resolution (see page 161, ante), was read:

Resolved by the Common Council and Board of Aldermen of the City of Indianapolis, That the plans, drawings and specifications prepared by D. A. Bohlen, Architect, for the construction of a Market House and Assembly Hall on the East Market Square, under the provisions of G.O. No. 7, 1885, heretofore exhibited to the members of the Common Council and Board of Aldermen, be, and the same are hereby, approved and adopted as the plans and specifications by which said buildings shall be erected.

And it was concurrently adopted by the following vote:

AYES, 8-viz. Aldermen Bernhamer, Cox, Endly, King, Prier, Pritchard, Tallentire, and President Rorison. Nays-None.

The following resolution (see page 161, ante), was read:

Resolved by the Common Council and Board of Aldermen of the City of Indianapolis, That the Building Committee contemplated and provided for by Section four of the ordinance of March 9th, 1885, entitled "An ordinance providing for the erection of a Market House and Public Buildings on the grounds known as the East Market Square, in the City of Indianapolis," is hereby selected, and made to consist of the following members, to-wit: The Mayor, the President of the Board of Aldermen, Councilmen John R. Pearson and Joseph H. Sheppard, and Alderman Isaac King.

Alderman Bernhamer presented the following protest; which was ordered printed in the Proceedings:

I hereby enter my protest against the passage of so much of the resolution creating the Board for the erection of the new Market House and City Hall as names the members thereof, for the following reasons:

It leaves all that part of the City of Indianapolis lying south of Washington street with but one representative.

Because the Council exceeded its functions in naming the democratic members of the Board from the Board of Aldermen.

The resolution was then concurrently adopted by the following vote:

AYES, 7-viz. Aldermen Cox, Endly, King, Prier, Pritchard, Tallentire, and President Rorison.

On motion, the Board then adjourned to meet at the call of the President.

The President called the Board to order again, a quorum present, the following entitled ordinances (passed by the Common Council at the session held this evening), were severally read the first time:

- G. O. 9, 1885—An ordinance granting John B. Doris the privilege of exhibiting his Circus and Menagerie for two days in the City of Indianapolis free of charge for license.
- G. O. 10, 1885-An ordinance granting C. F. Schmidt the right to lay and maintain a hand or horse car track in and along High street.

On motion by Alderman Pritchard, the rules were suspended for the purpose of placing the above ordinances on their final passage by the following vote:

Ayes, 7—viz. Aldermen Bernhamer, Cox, Endly, King, Prier, Pritchard, and Tallentire.

NAYS-None.

G. O. 9, 1885, was then read the second time, read the third time, and passed by the following vote:

AYES, 7-viz. Aldermen Bernhamer, Cox, Endly, King, Prier, Pritchard, and Tallentire.

NAYS-None.

G. O. 10, 1885, was read the second time.

Alderman Bernhamer offered the following amendment, to the above ordinance; which was adopted:

I move to amend by striking out the words "C. F. Schmidt" wherever they occur in the ordinance, and inserting in lieu thereof the words "John W. Schmidt and Edward Schmidt, doing business under the firm name and style of C. F. Schmidt."

The ordinance was then ordered engrossed as amended, read the third time, and passed by the following vote:

Aves, 7-viz. Aldermen Bernhamer, Cox, Endly, King, Prier, Pritchard, and Tallentire.

NAYS-None.

On motion, the Board of Aldermen then adjourned.
