PROCEEDINGS OF BOARD OF ALDERMEN.

SPECIAL SESSION—OctoBer 30, 1885.

The Board of Aldermen of the City of Indianapolis, met in the Aldermanic Chamber, Friday evening, October 30th, 1885, at half-past seven o'clock, in special session, pursuant to the following call:

PRESENT—Hon. Brainard Rorison, President of the Board of Aldermen, in the Chair, and Aldermen Bernhamer, Cobb, Endly, King, McHugh, Prier, Pritchard, and Tallentire—9.

ABSENT-None.

The following entitled ordinance was taken up, read the second time, and then read the third time:

G. O. 29, 1885—An ordinance requiring saloon keepers to pay an annual license of forty-eight dollars for the use of the General Fund of the City of Indianapolis.

And it was passed by the following vote:

AYES, 6-viz. Aldermen Cobb, Endly, Prier, Pritchard, Tallentire, and President Rorison.

NAYS, 1-viz. Alderman McHugh.

Aldermen Bernhamer and King arrived in the Aldermanic Chamber at this time.

The following entitled ordinance was then read the second time;

Ap. 0. 47, 1885—An ordinance appropriating the sum of Three Thousand (\$3,000) Dollars, on account of improving the State Ditch, in the City of Indianapolis.

Alderman Bernhamer moved to strike from the ordinance the clause requiring the sum expended "to be taken from the Special Sewer Fund."

Which failed of adoption, by the following vote:

NAYS. 3-viz. Aldermen Bernhamer, King, and McHugh.

Alderman Pritchard was excused for the remainder of this session.

INTRODUCTION OF MISCELLANEOUS BUSINESS.

President Rorison offered the following motion; which was adopted;

That the City Attorney be, and he is hereby, requested to prepare and have reintroduced in the Council, the resolutions which were introduced in that body about two years since, looking to the straightening the boundaries of the city.

On motion, the Board of Aldermen then adjourned.
