Gentlemen: — Your Hospital Board, to whom was referred the charges of Dr. H. W. Ridpath against the management of the City Hospital as conducted by Dr. W. N. Wishard, beg leave to report that we have thoroughly examined into said charges; have held about twenty meetings of said Board; have examined fifty-seven witnesses, and after patiently hearing all the evidence, and carefully consid-ering said testimony, we find that the evidence does not sustain the charges; and we therefore exonerate Dr. Wishard from all blame in this matter.

We therefore ask that the Hospital Board be discharged from further consideration of said charges.
