## PROCEEDINGS OF JOINT CONVENTION.

## THIRD SESSION—FEBRUARY 5, 1886.

The Common Council and Board of Aldermen of the City of Indianapolis, convened in third Joint Convention, in the Council Chamber, Friday evening, February 5th, A. D. 1886, at eight o'clock, pursuant to adjournment.

PRESENT—Hon. Caleb S. Denny, Mayor, Temporary President of the Joint Contion, in the Chair, and 35 members, viz: Aldermen Brown, Crosby, King, Laut, Prier, Pritchard, Rail, Schmidt, Wright, and President Endly; Councilmen Benjamin, Burns, Coy, Cummings, Dell, Dunn, Edenharter, Haugh, Herig, Howes, Mack, Markey, McClelland, McGroarty, Newland, Pearson, Reinecke, Reynolds, Rooker, Smith, Smither, Stuckmeyer, Swain, Thalman, and Waterman—35.

ABSENT-None.

Alderman Schmidt, on behalf of the Special Committee appointed at the first session of the Joint Convention, submitted the following report; which was read:

To the President and Members of the Joint Convention of the

Common Council and Board of Aldermen of the City of Indianapolis:

1 Gentlemen:—Your Committee beg leave to report that since our last adjournment, the case of the State of Indiana on the relation o' Alderman Rail against Mayor Denny—the same being cause No. 34,923, in the Marion Superior Court—has been decided by Judge Walker, the other judges of said court unanimously concurring therein. The judgment of the court in that case is, that Alderman Rail was duly elected President of, and is rightfully entitled to preside over, this Joint Convention. Your Committee is further advised, and so report, that the logical sequence of that decision is, that the Mayor of the city is not entitled to a vote in this joint body. The decision of the Marion Superior Court, contained in the foregoing report, having declared Alderman John Rail to be the duly elected President of the Joint Convention, His Honor, the Mayor, retired from the Chair, and Alderman Rail took the Chair, and assumed the duties of President of the Joint Convention.

The President announced that the election of the official boards was in order.

Councilman Thalman moved that the Joint Convention proceed to elect a Board of Public Improvements, a Hospital Board, and a Dispensary Board, in the order named; which was agreed to.

The President appointed Alderman Wright and Councilman Burns as Tellers.

For Board of Public Improvements, Councilman Pearson placed in nomination Councilmen Herig, Stuckmeyer and McClelland.

Councilman Coy placed in nomination Councilmen Stuckmeyer, Reynolds and Herig.

A ballot was then had, which resulted as follows:

Councilman Herig received 35 votes. Councilman Stuckmeyer received 35 votes. Councilman McClelland received 18 votes. Councilman Reynolds received 17 votes.

Councilmen Herig, Stuckmeyer and McClelland having each received a majority of all the votes cast, they were declared by the President as duly elected members of the Board of Public Improvements.

For Hospital Board, Councilman Coy placed in nomination Councilmen-Edenharter, Dunn and Swain.

On motion by Councilman Pearson, the Secretary was instructed to cast the unanimous vote of the Convention for Councilmen Edenharter, Dunn and Swain.

Which was done, and they were declared by the President duly elected members of the Hospital Board.

For Dispensary Board, Councilman Thalman placed in nomination Councilmen McGroarty, Newland and Rooker.

Councilman Coy placed in nomination Councilmen Dell, Smither and McClelland.

A ballot was then had, which resulted as follows:

Councilman McGroarty received 18 votes.

Councilman Newland received 22 votes.

Councilman Rooker received 19 votes.

Councilman Dell received 16 votes.

Councilman Smither received 17 votes.

Councilman McClelland received 11 votes.

Scattering, 2 votes.

Councilmen McGroarty, Newland and Rooker having each received a majority of all the votes cast, they were declared by the President as duly elected members of the Dispensary Board.

That this Joint Convention now adjourn, to meet upon a call of a majority of Councilmen and Aldermen.

Councilman Coy moved to lay the motion on the table.

Which failed of adoption, by the following vote:

AYES, 17-viz: Aldermen Crosby, King, Laut, and Schmidt; Councilmen Burns, Coy, Dell, Edenharter, Haugh, Howes, Mack, Markey, Newland, Reinecke, Stuckmeyer, Waterman, and President Rail.

NAYS, 18—viz: Aldermen Brown, Endly, Prier, Pritchard, and Wright; Councilmen Benjamin, Cummings, Dunn, Herig, McClelland, McGroarty, Pearson, Reynolds, Rooker, Smith, Smither, Swain, and Thalman.

Councilman Coy moved to amend the motion by making the adjournment subject to the call of the President.

Councilman Pearson moved to lay the amendment on the table.

Which was adopted, by the following vote:

AYES, 18--viz: Aldermen Brown, Endly, Prier, Pritchard, and Wright; Councilmen Benjamin, Cummings, Dunn, Herig, McClelland, McGroarty, Pearson, Reynolds, Rooker, Smith, Smither, Swain, and Thalman.

NAYS, 17—viz: Aldermen Crosby, King, Laut, and Schmidt; Councilmen Burns, Coy, Dell, Edenharter, Haugh, Howes, Mack, Markey, Newland, Reinecke, Stuckmeyer, Waterman, and President Rail.

The question being on the adoption of the original motion offered by Councilman Pearson, a vote was had, which resulted as follows:

AYES, 18--viz: Aldermen Brown, Endly, Prier, Pritchard, and Wright; Councilmen Benjamin, Cummings, Dunn, Herig, McClelland, McGroarty, Pearson, Reynolds, Rooker, Smith, Smither, Swain, and Thalman.

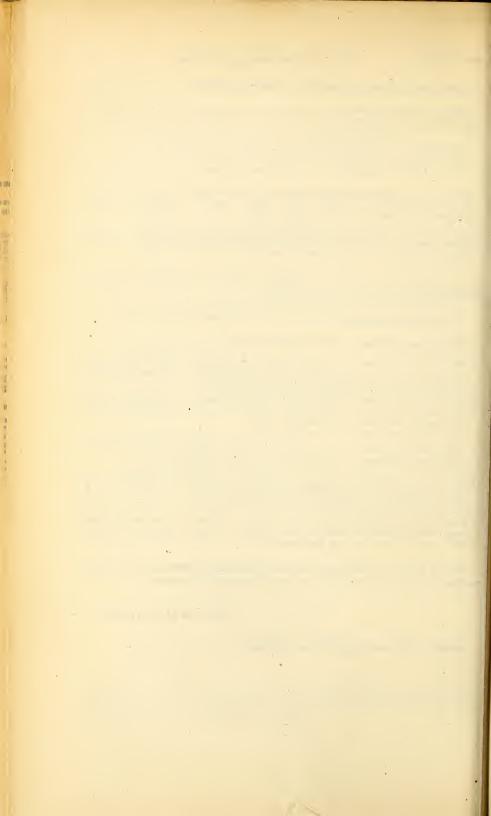

# Proceedings of Common Council.

## ADJOURNED SESSION—FEBRUARY 5, 1886.

The Common Council of the City of Indianapolis, met in the Council Chamber, Friday evening, February 5th, A. D. 1886, at 8:30 o'clock, pursuant to adjournment.

PRESENT—Hon. Caleb S. Denny, Mayor, and ex officio President of the Common Council, in the Chair, and 25 members, viz: Councilmen Benjamin, Burns, Coy, Cummings, Dell, Dunn, Edenharter, Haugh, Herig, Howes, Mack, Markey, Mc-Clelland, McGroarty, Newland, Pearson, Reinecke, Reynolds, Booker, Smith, Smither, Stuckmeyer, Swain, Thalman and Waterman. ABSENT—None.

On motion by Councilman Thalman, the action of the Common Council at the last meeting, authorizing a temporary loan of thirty thousand dollars, at  $4\frac{1}{2}$  per cent. interest, was reconsidered.

Councilman Thalman, for the Committee on Finance, offered the following resolution :

WHEREAS, The City of Indianapolis is in present need of funds to defray its necessary running expenses; and

Whereas, It has therefore become necessary to provide for such present necessities, by making a temporary loan in anticipation of the city's current year's revenues; therefore, be it

Resolved by the Common Council and Board of Aldermen of the City of Indianapolis, That a temporary loan of thirty thousand dollars 'or said city, be, and the same is hereby ordered, the same to mature on or before May 12th, 1886, and to draw not exceeding five per cent. interest per annum from date.

And Resolved. further. That the Mayor and City Clerk be, and they are hereby, authorized and directed to sign and deliver to the lender, the proper time warrants or bonds of said city, for said amount, drawing not exceeding said rate of interest, upon delivery to said Clerk by the County Treasurer, of a receipt showing that he has received and placed said sum to the credit of the city.

That the City Clerk be, and is hereby, instructed to prepare a list of the different committees of the Council and Board of Aldermen, and have the same printed for use of the members.
