SPECIAL SESSION—FEBRUARY 24, 1886.

The Common Council of the City of Indianapolis, met in the Council Chamber, Wednesday evening, February 24th, A. D. 1886, at eight o'clock, in special session, pursuant to the following call:

Gentlemen:—We, the undersigned, citizen tax payers, and residents of the Fifteenth Ward of said city, west of White River, humily represent to your honorable be ies that we are desirous of having the old Lafayette Road, running north from Bloomington street, in said city; up said River as far north to Vermont street, opened; believing that said improvement will be a great benefit and lasting improvement to the citizens of said Ward and the public generally. The banks of said River being washed away, together with a large portion of said road within said limits, it is now difficult for a foot way person to pass securely at places within said limits. The rip-rap that your honorable body caused to be placed along the banks of said River being in some places nearly washed into the said River, or so much impaired that it has become useless, and of no utility whatever. The travel on the west side of said road is great, and persons coming to the city to do business on Washington street, north and south, have no thoroughfare to travel but over Michi-

gan street bridge. We therefore pray your honors to examine and adhere to the prayer of your petitioners; and in duty bound, we will ever pray, &c.

Councilman Thalman offered the following motion; which was referred to the Committee on Public Property:

That the City Civil Engineer be directed to advertise for proposals for laying a brick pavement through Circle Park.

Councilman Waterman presented the following petition; which was read and received:

To the Common Council of the City of Indianapolis:

Gentlemen: - The undersigned, Isaac S. Reed, of the City of Indianapolis, Ind., would respectfully represent to the Common Council of said city, that he is of the age of sixty years; is in poor health, and unable to perform manual labor; that he is poor, and is desirous of engaging in a small business, and constructing a stand

for such purpose at the curve of the northeast corner of the Court House enclosure, in said city; that if suffered so to do, he will in no manner obstruct the walk or way. He shows that the Board of County Commissioners consent thereto, and he herewith presents such assent. For such purpose he asks that your body, by appropriate action, grant the request asked, under such limitations and restrictions as may be deemed proper.

The following entitled ordinance was read the second time, ordered engrossed, and read the third time:

S. O. 18, 1886—An ordinance to provide for grading and graveling Tenth street and sidewalks, from Central avenue to Greenwood street.

And it was passed by the following vote:

To the Mayor and Common Council:

Gentlemen:—The Board of Aldermen, in regular session held in the Aldermanic Chamber, Monday evening, February 22d, 1886, non-concurred in your action in accepting the proposition of the sureties on the official bond of Isaac N. Pattison, late City Treasurer, to pay and secure to the city the sum of sixty-eight thousand dollars (\$68,000) in full satisfaction of all claims against said Pattison and his bondsmen on said bond.

Alderman King moved to reconsider the vote by which the above motion failed; which was adopted, and the motion to appoint a Conference Committee was then adopted.

The President appointed Alderman Rail, Laut and Pritchard as the above committee.

Alderman Prier moved that the Board now adjourn to meet next Monday night.
