The report from the Committee on Judiciary, on the claim of W. A. & E. M. Pattison (see pages 653 and 654, *ante*), was read, and the favorable action of the Common Council thereon concurred in.

The report from the Special Committee on Washington Street Improvement, (see page 655, *ante*), was read, and the favorable action of the Common Council thereon concurred in.

The report from the Building Committee on Market House and Public Buildings (see pages 655 and 656, *ante*), was read, and the favorable action of the Common Council thereon concurred in.

The report from Special Committee on Fire Department to purchase a Hose Wagon for No. 5 Engine House (see page 656, *ante*), was read, and the favorable action of the Common Council thereon concurred in.

Robinson et al., praying for the widening of Alabama street to a width of sixty feet, by taking fifteen feet off of the real estate on the east side of said Alabama street from Merrill street to McCarty street, be referred to the City Commissioners with instructions to assess benefits and damages, and to make due report to the Common Council and Board of Aldermen, the Commissioners to return all petitions and notices. The City Clerk is hereby required to issue the proper notices, and the Superintendant of Metropolitar. Police is hereby directed to serve the notices upon the City Commissioners and property owners.

Morris' addition to the City of Indianapolis, Indiana, be, and they are hereby, required to fill or drain the same, as, in the opinion of the Council. twere is a hole or excavation thereon, in which water has or may become so stagnant or noxious as to be a nuisance and injurious to the health and comfort of said city and of the inhabitants thereof. and that the Street Commissioners be, and he is hereby required to notify the owners thereof, as provided by an ordinance passed April 28, 1866, entitled, "An ordinance providing for the drainage and filling up of ponds, excavations and holes, and prescribing penalties for the failure to fill or drain the same." and that in case of the failure of the owners thereof to fill or drain the same. The Street Commissioner proceed to fill or drain the said hole or excavation as provided in said ordinance, *Provided*, that the cost thereof shall not exceed ten per cent. of the value of the aforesaid real estate, as assessed upon the tax duplicate for city purposes.

The whole truth of the matter is, that the wholesalers, as they
