# REGULAR SESSION-October 4, 1886.

The Common Council of the City of Indianapolis, met in the Council Chamber, Monday evening, October 4th, A. D. 1886, at 7:30 o'clock, in regular session.

The City Attorney submitted the following report; which was concurred in:

To the Mayor, Common Council and Board of Aldermen:

Gentlemen:—Since the last meeting of the Council, the suit of Emogen E. Woodall vs. The City, has been tried, and the jury returned a verdict for the city. This was an action for damages in the sum of \$10,000, for injuries resulting from a fall on the north sidewalk of Washington street, in front of the Fancy Bazaar. Plaintiff claimed that the breaking of her leg was caused largely by the very great slant in the sidewalk at that place; the slant at that place being eleven inches in about fifteen feet. Your attention was called to this sidewalk by my predecessor, His Honor, the Mayor, when he was the City Attorney, and I have had prepared an ordinance which I think will correct this slant, and which I present with this report, and earnestly urge its speedy passage. I also present herewith a motion instructing the Street Commissioner to order all owners of property fronting on Washington street, between Delaware and Illinois streets, to roughen all stone pavements in front of their property, as by him directed, and recommend that this motion be adopted.

Report of the City Commissioners in the matter of opening and extending Lincoln Lane.

To the Mayor, Common Council, and Board of Aldermen of the City of Indianapolis:

Gentlemen:—The undersigned, members of the Board of City Commissioners of said city, duly appointed, sworn, qualified and acting under and in pursuance of an Act of the General Assembly of the State of Indiana, in relation to the laying out, opening, widening, altering and vacation of streets, alleys, &c., approved March 17th, 1875, and acts amendatory thereto, do report:

1st. That in pursuance of a notice of the City Clerk, herewith filed as a part hereof, marked exhibit "A," they met in Room 2, of the City Clerk's office, on Friday, the 30th day of July, 1886, and entered into the consideration of the petition of B. W. Hartley et al, for the opening of Lincoln Lane on a straight line to the width of sixty feet from the present eastern terminus of said Lincoln Lane to Shelby street.

2d. After having viewed the ground proposed to be taken for the extension of said street, and the property contiguous thereto and along the line of said street to East street, with a view of determining what property was benefited and what property damaged by said street extension, the Commissioners agreed on the inter-

ested parties, and the City Clerk was required to have the proper notices issue, notifying the property owners to meet the City Commissioners in Room 2, of the City Clerk's office, on Monday, the 27th day of September, 1886, at 10 o'clock A. M. Said report to the City Clerk is herewith filed as a part hereof, and marked exhibit "B."

3d. We further report that we met at the time and place named, and entered upon the further consideration of opening said street, by examining various wit-

nesses and interested parties in relation to said street opening.

4th. We now, on said 27th day of September, 1886, report that there is no damage to any property on account of said proposed opening and extension of Lincoln Lane, except where a portion of property is taken therefor, and to a narrow strip of land cut off by said street extension and detached from the body of the land to which it belongs, and also a damage to a barn which stands partly in the street.

5th. Said opening runs from the present eastern terminus of Lincoln Lane to

Lyon be, and is hereby, granted permission to grade and pave with brick, the sidewalk alongside of his property, south side of Lincoln avenue, from College avenue to the first alley east of College avenue; work to be done at his own expense, under the direction of the City Civil Engineer.

That Wm. G. Wasson be granted the privilege of erecting a private telephone line from the corner of North street and the Canal to No. 24 south Pennsylvania street, and to use the poles of the city where he can, under the direction of and subject to removal by the Chief Fire Engineer.

Councilman Thalman presented for approval, a plat of Herman W.
