





An Ordinance amendatory of an Ordinance entitled an Orcinance relative to nuisasices and other offences against the police of the City of Indianapolis passed April 20th 1852. Sec.lst Be it Ordained by the Common Council of the City of Indianapolis that the fifth Section of an Ordinance entitled an Ordinance relative to nuisances and other offences against the police of the City of Indianapolis". Which reads as follows. Any person or persons who shall deposet or cause to be deposited in any of the squares, Streets or alleys of this City any timber, wood, rails, posts or any material of any description whatever and suffer the same or any part thereof to remain therein for a longer period than twenty four hours after being notified by the Marshall to remove it, shall on conviction thereof forfeit and pay the sum of three dollars for every twenty four hours the same shall continue after the expiration of said term of twenty four hours, provided that persons engaged in building or making pavements may deposit material for such building or pavement in any of the Streetsor alleys for a reasonable time, but no person shall be authorized to fill up any gutter or channell for the passage of water or so obstruct the said streets or alleys as to prevent the passage of carriages or occupy more than two thirds of such street or alley. Shall be amended to read as follows,

Any person or persons who shall deposit or cause to be deposited in any of the squares, streets or alleys of this City any timber, wood, rails, posts or any material of any description whatever and shall suffer the same or any part thereof to remain therein for a longer period than twenty four hours after being notified by the Street Commissioner to remove it shall on conviction thereof forfeit and pay the sum of three dollars for every twenty four hours the same shall continue after the expiration of the said term of twenty four hours, provided that persons engaged in building or making pavements, by making application to the Common Council for a permit stating the time required to complete such building which time shall not exceed

One hundred days may deposite material for such building or pavement in any of the Streets or alleys for the time permited by the Common Council, but no person shall be authorized to fill up any gutter or channele for the free passage of water or so obstruct the said Streets or alleys as to prevent the passing of Carriages or occupy more than one third of such Street or alley.
