CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Saturday, October 14, 1871, 7 o'clock, P. M.

The Common Council met pursuant to adjournment.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Sealed proposals for the improvement of streets, alleys, sidewalks, &c., were opened, read, and referred to the Committee on Contracts.

Mr. Brown presented the following remonstrance :

INDIANAPOLIS, IND., Oct. 14, 1871.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN—The undersigned, property holders in the city of Indianapolis, learning that your honorable body is about to let contracts for grading and paving sidewalks in portions of the city, respectfully request your honorable body to postpone the letting of said contract on Virginia avenue, between East street and the corporation line, as the winter is approaching, and to do this work at this season of the year would subject the owners to an expense they can illy afford, and in some cases cause actual suffering.

The City Attorney made the following report:

INDIANAPOLIS, Ootober 14, 1871.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN—It is my duty to report to you that the case of Francis Donnelly vs. The City of Indianapolis, pending in the Marion Civil Circuit Court, was, on the 26th of September ult., dismissed at the costs of the plaintiff. The suit was brought to recover damages for an alleged overflow of the plaintiff's premises.

That the case of Messrs. Lawyer & Hall against the City of Indianapolis, for damages on account of a recent overflow of their premises on South New Jersey street, was tried on the 20th ult. in the Superior Court of Marion county by a jury, who rendered a verdict against the city for six hundred dollars.

That in pursuance of authority recently conferred on me by the Common Council, I compromised the case of John Wands against the City of Indianapolis, to recover damages for an alleged overflow of his premises, and by agreement a judgment was rendered in the Marion Civil Circuit Court in favor of said Wands and against the city, for fifty dollars and costs. I ask you to approve my action in the last named case.

Mr. Bigham introduced Special Orninance No. 135, 1871, entitled :

An Ordinance to grade and gravel the first alley north of Ohio street, running from Davidson to Winston street.

Mr. Bigham offered the following motion :

Moved: That Messrs. Thein & Frank have permission to put a sign across the alley running between Liberty and Noble, and Market and Ohio streets, said sign to be 12 feet above the level of the alley.

Mr. Cottrell offered the following petition:

Moved: That Robert Connelly be and is hereby granted the privilege of laying a brick pavement in front of his property on the corner of Alabama and North streets, and also to build coal vaults under the same, to be done in sixty days, and under the direction and to the satisfaction of the Civil Engineer.

Mr. Gimber presented the following petition:

The work to commence within ten days from this date, and that a notice of the above order be presented by him to the officers of said road.

Mr. Thalman introduced Special Ordinance No. 137, 1871, entitled :

An Ordinance to pave with brick the north sidewalk of New York street; from Indiana avenue to Mississippi street.

Which was read the first time.

Mr. Whitsit presented the following petition :

INDIANAPOLIS, October 14, 1871.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN—Your petitions owners of real estate and residents of the city of Indianapolis, respectfully represent that the two large out-lots numbered ninety-nine (99) and one hundred (100), in the southearst part of the city, are upon high grounds, but the land lays flat and level, and has holes and large natural ponds in it, and having a clay bottom the water from the rains and other sources can not sink into the earth, and there being no drainage the water lays stagnant in these holes and ponds, and causes fever and ague. Drainage would carry the either to Delaware street or to East street at the sewer. There is no part of the city where the same amount of expense would accomplish so great a result for the benefit of the citizens. We therefore pray that the city order an underdrain or sewer to carry off such surplus water, and pass such ordinances as in the opinion of the Council will produce the requisite drainage.

Mr. Batty, from the Committee on Revision of Ordinances, made the following report:

INDIANAPOLIS, October 14, 1871.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN--Your Committee on Revision of Ordinances, to whom was referred sundry resolutions to annex certain territories to the city, would beg leave to make a partial report on said resolutions, to-wit:

They recommend that Morrison's third addition be annexed to the city; or rather, so much of the resolution so referred as suggests to the annexation of Morrison's third addition to the city be adopted. And said Committee ask further time to consider of the remainder of said annexation resolutions.
