The City Attorney made the following report:

INDIANAPOLIS, Nov. 6, 1871.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN—I have to report that in the case of Frederick Wuench against the city of Indianapolis, in the Superior Court of Marion county, which was an appeal from the assessment of the value of lot No. 32, in Coffman's subdivision of the north part of outlot No. 101, with the improvements thereon, by the City Commissioners, they assessing the same at \$700.

After the papers in the appeal were filed, one Frederick Jasper asked to be made a defendant, was so made, and showed to the court by answer that he had a lien on said lot amounting to \$96.08, on the 4th of October, 1871.

The Superior Court, after hearing the evidence, adjudged and decreed as follows:

That if the said city of Indianapolis do decide and determine to use and appropriate the said real estate of the plaintiff, she shall first pay the sum of eight hundred and fifty dollars (\$850), therefor, and out of said sum the lien of the defendent, Frederick Jasper, shall first be paid and satisfied. Judgment was rendered against the City for costs.

On this judgment or assessment Messrs McDonald, Butler & Mc Donald have filed or entered on the records of the Superior Court, their intention to hold a lien thereon for fifty dollars, fee for their services as attorneys for the plaintiff.

In addition to the above liens, I find that there are the following:

Upon the trial of the case it was ordered, adjudged and decreed by the Court, that if the city of Indianapolis does decide and determine to use and appropriate the real estate of the plaintiff, she shall first pay the sum of \$850 therefor; and out of said sum the lien of said Jasper shall be first paid and satisfied; also judgment against the City for costs, taxed at \$23.10.

Now the question is, will the Council order or direct the Treasurer to pay the said sum of \$850?

In my opinion, as the matter now is, you can't do so, and issue precepts against the parties benefitted, as the City Commissioners report. If they will all agree in writing to pay the assessments, then it perhaps would bind them; nothing else will.

I therefore recommend that the Couucil refuse to appropriate the lot for said street purposes, and that all orders for precepts be refused; and that you order that the costs, amounting to \$23.10, be paid.

We think the city is not liable, and that we will be able to show that to be so in the Supreme Court.

INDIANAPOLIS, Nov. 6, 1871.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN—As my health is such that I cannot be out at night to see you in person, I wish to say to you in relation to the extension of Market street through my ground, that I shall be glad to have you postpone the same, and give me time to lay before you the facts as to the inconvenience as well as the damage it will be to me, to extend it just now. I know not what report your Commissioners may make, but I do know that Commissioners generally have an

easy way of getting clear of trouble by saying the gain is equal to the loss. Permit me to say a few more words in relation to this last The loss of my ground, (though to me it is valuable,) is remark. not the consideration with me, as the subjecting me to pay all the improvement of street, sidewalks, drainage, etc., beside two fences, gates, etc., making a cost perhaps of some ten or fifteen hundred dollars, and yet be of but little advantage to the traveling public, it being so near the end where it closes up; such travel would always have to return to Washington street, as it is only about 300 feet from it. But if the street is wanted, and it is necessary to open it, I am a law abiding man, and am willing to extend the street as soon as I can, and give the ground, bat I must beg of you to allow me at least enough to pay me for all other expense, such as grading, graveling street and sidewalks. I will not ask pay for fencing, gates, etc., which I will be obliged to have, beside the great inconvenience of ingress and egress, besides spoiling my little retired homestead. If the Commissioners report without damage, then I must rely upon you to do me justice, otherwise I shall have to go further, which I hope I shall not have to do. With confidence in your wisdom and justice, I submit this matter, ror the present, to your consideration.
