REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, November 20, 1871, 7 o'clock P. M.

The Common Council met in regular session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

The proceedings of the regular session held November 13th, 1871, were read and approved.

Scaled proposals were opened, read, and referred to the Committee on Contracts.

By unanimous consent, Dr. Mears addressed the Council in relation to the recent burning of the Pest House, and asked that the Council take some action towards rebuilding the same.

On motion by Dr. Woodburn, Dr. Mears, Superintendent of the Pest House, and the Committee on Public Buildings, were instructed to rebuild the Pest House at a cost not exceeding one thousand dollars.

Moved; That the Street Commissioner be directed to notify the property holders of the lots fronting on the south side of Washing-

ton street, between Delaware and Alabama streets, to at once repair the sidewalk on the south side of Washington street between said Delaware and Alabama streets; and if the same is not so done to the satisfaction of said Street Commissioner within ten days from the time of such notice, that the Street Commissioner cause the same to be repaired at the expense of the said property owners respectively.

Moved; That the Street Commissioner be directed to notify the Madison and Jeffersonville Railroad Company to plank the crossing of South street sidewalks with good oak plank; and if not done in ten days, the same to be done under the direction of the Street Commissioner, and the same to be charged to the said railroad company.

GENTLEMEN—Whereas, we the property holders of lots 15, 16, 17, and 18, in out-lot or square No. 140, having received notice that on the 9th day of December, 1871, at 9 o'clock A. M., a meeting is to be held at Room No. 2, City Hall, for the purpose of opening an alley ten feet wide—five feet to be taken from the west ends of lots 15, 16, 17 and 18, and five feet from the east side of lot 16, in out-lot No. 140, pray your honorable body not to grant such petition, nor appoint commissioners to assess such damage, as such an alley is not needed; nor are any of the property holders desirous of any such

Moved; That W. J. Wallace and Cager Wright be allowed to grade and gravel the alley between their property, being lots 482, 483, 484, and 485, in out-lot 94, and that the Civil Engineer be instructed to set the grade stakes.

Moved; That the Rev. Charles Tinsley be allowed to grade and pave, with brick or other suitable material, the sidewalk in front of his property on the corner of Huron and School streets.
