# REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, November 20, 1871, 7 o'clock P. M.

The Common Council met in regular session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Batty, Bigham, Brown, Cottrell, Craft, Gimber, Heckman, Kennington, Locke, Marsee, Newman, Reagan, Thalman, Thoms, Weaver, Whitsit, Wiles and Woodburn-18.

The proceedings of the regular session held November 20th, 1871, were read and approved.

Proposals for "cast iron foot crossings" were received, opened, read and referred to Committee on Contracts.

The Committee on Contracts made the following report:

# INDIANAPOLIS, Nov. 27, 1871.

# To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN—Your Committee on Contracts, to whom was referred sundry proposals for various street improvements, have examined the same, and find the following named persons to be the lowest and best bidders, and would recommend that the contracts be awarded as follows, to-wit:

#### FIRST.

For grading and graveling Tinker street and sidewalks, from the east side of Meridian to the east line of the wide portion of Illinois street, to James Mahoney, at eighty cents per lineal foot front on each side of the line improved.

### SECOND.

For grading and graveling Tinker street and sidewalks from the east line of the wide portion of Illinois street, to the Michigan road or Central Canal, to J. J. Palmer, at sixty-nine cents per lineal foot front on each side of the line improved.

### THIRD.

For grading and graveling Tinker street and sidewalks, from the east side of Meridian street to the south-west corner of W. H. Talbott's property, to James Mahoney, at eighty-five cents per lineal foot front on each side of the line improved.

### FOURTH.

For grading and graveling Tinker street and sidewalks, from the south-east corner of W. H. Talbotts property to the east side of Western avenue or Fall Creek gravel road, to Samuel Hanway & Co., at ninety-two cents per lineal foot front, on each side of the line improved.

#### FIFTH.

For grading and graveling Alabama street and sidewalks from the north side of St. Mary street to the north side of Morrison street, to

J. J. Palmer at eihgty-five cents per lineal foot front, on each side of the line improved.

### SIXTH.

For grading and bowldering the street and curbing, the outside edges with stone, East street, from Washington street to Pogues Run, to George W. Buchanan at two dollars and thirty-seven cents per front foot on each side for bowldering, and fifty seven cents on each side for curbing.

#### SEVENTH.

For grading the first alley west of Virginia avenue, running from East street through out-lot 102 to Merrill street, to tGeorge W. Buchanan, at nine and three quarter cents per lineal foot front on each side of the line improved.

#### EIGHTH.

For grading and graveling the first alley north of Ohio street, and running east and west from Davidson to Winston street, to David Sylvester at twenty-two cents per lineal foot front on each side of the line improved.

#### NINTH.

For grading and graveling Michigan street and sidewalks from Blackford to Blake street, to Patterson and Dunning at one dollar and twenty cents per lineal foot front on each of the line improved.

### TENTH.

For grading and graveling the west sidewalk on New Jersey street, between Merril and McCarty streets, to Hiram Seibert, at twenty-seven and one half cents per lineal foot front on the line improved.

### ELEVENTH.

For grading and paving with brick the east sidewalk on Virginia avenue from East to New Jersey streets, and repairing that already laid down, at sixty cents per lineal foot front for the new pavement, and twenty dollars for repairing the old now down on the line proposed to be improved, to Edward Wessert.

# TWELVTH.

For grading and graveling Greer street and sidewalks, from Stevens to McCarty street, there was no proposals presented, we therefore recommend that the same be readvertised.

# THIRTEENTH.

For grading and paving with brick the north sidewalk on Huran street, from Virginia avenue to Noble street, to R. P. Dunning at sixty-five cents per lineal foot front on the line improved.

## FOURTEENTH.

For grading and paving with brick the north sidewalk on New York street, from Indiana avenue to Mississippi street, to Edward Wessert at sixty cents per lineal foot front on the line inproved.

### FIETEENTH.

Far grading and paving with brick, and curbing the outside edges with Flat Rock stone, the east sidewalk on New Jersey street, from Washington street to Pogues Run, to James K. Frost at sixty cents per front foot for paving, and fifty-three cents per front foot for curbing.

### SIXTEENTH.

For grading and paving with brick the sidewalks on South street, from Noble to East street, to R. P. Dunning, at sixty-five cents per lineal foot front on each side of the line improved.

### SEVENTEENTH.

For grading and graveling the alley running north and south from Buchanan to Daugherty street, between lots 176, 177, 140 and 141, in Daugherty's subdivision of outlot No. 99, to Huffington & Foust, at  $24\frac{1}{2}$  cents per lineal foot front on each side of the line improved.

#### EIGHTEENTH.

For grading and paving with brick the sidewalks on Fletcher avenue, from Noble to Cedar street, to R. P. Dunning, at sixty-five cents per lineal foot on each side of the line improved.

GENTLEMAN:—At the request of the Mayor and City and State Prosecutors, I have appointed Charles E. Harris, Deputy Marshal, for the purpose of making collections on the City and State Dockets prior to May 1871. I most respectfully ask your honorable body to confirm the appointment.

# INDIANAPOLIS, Nov. 27, 1871.

### To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN—Your Committee on Bridges, to whon was referred the bids for the construction of an iron bridge or via-duct, over the railroad tracks at their crossing on Delaware street, beg leave to report that they find the bid of the "Massileon Wrought Iron Bridge Co." to be the lowest, viz. thirty-four dollars and fifty cents (\$34.50) per lineal foot for the entire construction, we therefore recommend that the contract be awarded to them for the construction of said work, according to plans and specifications to be furnished by the Civil Engineer.

The bond an dcontract is herewith submitted for your approval.

Mr. Cottrell moved to amend by inviting bids for the construction of a tunnel, either of iron, stone, or brick.

Which was adopted.

Mr. Brown's motion as amended was then adopted.

Mr. Brown moved to take up the motion of Mr. Wiles, offered at last meeting of the Council, which contemplated the reconsideration of the vote, by which General Ordinance No. 41, 1871, was passed.

Which was adopted and Mr. Wiles motion taken up.

Mr. Brown then moved to lay the motion to reconsider on the table.

Which was adopted.

# Mr. Heckman presented the following petition:

### INDIANAPOLIS, Nov. 27, 1871.

# To the Mayor and Common Council of the City of Indianapolis:

GDNTLEMEN—Your petitioners would respectfully show to your honorable body that, on the 16th day of October, 1871, in the case of Fredrick Guasburgh, Wm. Cook, et. el. vs. the Common Council of the city of Indianapolis, Fredrick Thoms, et. al. The Marion Civil Circuit Court, on said day, made, in said case, the following order, judgment, and decree:

"The Court does order, adjudge, and decree, 1st. That the order made by said Common Council, on the 8th day of June, 1870, for the vacation of the first alley south of Pogues' Run, running east and west through out-lot or block 85, from East to Liberty street, in the city of Indianapolis, and all proceedings had by said Common Council under the petition of said defendants, Thomas Speigle et. al., of March 24th, 1870, set forth in said complaint, (being the complaint of the plaintiff in the suit above named) were and are null and void, and conferred no power or authority on any of said defendants to enclose or otherwise obstruct the free passage of the public through or upon said alley.

2d. That the defendants, and each of them, are perpetually enjoined from fencing up, enclosing, or in any other manner obstructing the free public use of said alley, under any supposed or pretended authority based upon the aforesaid action of said Common Council," etc.

Your honorable body having "exclusive power over the streets and alleys," etc., within said city of Indianapolis, having been perpetually enjoined by the decree above set out, from in any manner obstructing the free public use of said alley; and not having appealed from said decree of said Civil Circuit Court, and said alley now being obstructed to the great inconvenience and injury of your petitioners, they would respectfully ask your honorable body to order the City Marshal to remove all obstructions from said alley,

that the free public use of the same may no longer be obstructed, and your petitioners will ever pray, etc.

Moved: That the City Marshal notify Mrs. Kennedy to move her fence out of an alley in the rear of No. 340, Indiana avenue, to a line of her property, complaint being made that said fence now obstructs the said alley.

*Moved*: That the Street Commissioner be and is hereby directed to place stone crossing on Illinois street, on the crossings of New York and Vermont streets.
