CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS,
Wednesday, January 24, 1872, 7 o'clock P. M.

The Common Council met pursuant to adjournment.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Batty, Bigham, Brown, Cottrell, Craft, Heckman, Kennington, Locke, Marsee, Newman, Reagan, Thalman, Thoms, Weaver, Whitsit, Wiles and Woodburn—17.

Absent—Gimber—1.

The proceedings of the regular session held January 15th, 1872, were read and approved.

Mr. Craft, from the Committee on Contracts, made the following report:

Indianapolis, Jan. 24, 1872.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN—Your Committee on Contracts, to whom was referred sundry proposals for various street improvements, have examined the same and would recommend that contracts be awarded as follows, to-wit:

FIRST.

For grading and paving with brick the east sidewalk on Alabama street, between Walnut street and Fort Wayne avenue, to James W. Hudson, at sixty-two cents per foot front.

SECOND.

For taking up and relaying the brick pavement on the south side of New York street, from Tennessee street to a distance of a hundred feet west of Tennessee street, to Patterson and Dunning, at thirty-one cents per front foot.

THIRD.

For grading and graveling the alley running from Delaware street to the Jeffersonville railroad tracks on the west side, the said alley being the first alley north of South street, running east and west through square 98, to William Warrenburgh, at twenty-five cents per lineal foot front on each side of the line improved.

FOURTH.

For grading and graveling Locke street and sidewalks, from Indiana avenue to Margaret street, to Patterson and Dunning, at fifty-seven cents per front foot on each side of the line improved.

FIFTH.

For grading and graveling 220 feet of the east end of the alley r ning east and west through out-lot 175, between Delaware and Alabama streets, and between St. Joseph and St. Mary streets, to James Mahoney, at thirty cents per foot front on each side of the line improved.

SIXTH.

For furnishing castings for gutter crossings, to D. Root & Co. at three and one quarter cents per pound.

SEVENTH.

For erecting lamp posts, lamps and fixtures on Delaware street, between St. Mary and Second streets; on Gregg street, from New Jersey street to Park avenue, at \$31.50 for corner, and \$30.50 for intermediate posts, to D. Root & Co.

EIGHTH.

For placing the names of the streets on street lamps, to George T. Dalton at \$2.25 per lamp post.

Indianapolis, January 15, 1872.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN—I am instructed to report to you what steps are necessary (if any) to prevent the Bellefontaine Railroad Company from blocking up the crossing, at the intersection of Barrow street with the Pendleton gravel road.

I am informed that the street was never laid out across the strip of ground owned or occupied by the Railroad Company. If my information is correct, before the cars can be interfered with by the city authorities, the street must be extended across the land or track of the Railroad Company; this can only be done by a petition or resolution accompanied by a plat of the surroundings, being referred to the City Commissioners, who must report their assessment of the damages and benefits accruing, by reason of such extension, to the Council, which if accepted by the Council, and a proper ordinance

passed, will enable the city to prevent the "blocking up the crossing."
