REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, February 5, 1872, 7 o'clock P. M.

The Common Council met in regular session.

The proceedings of the regular session held January 29th, 1872, were read and approved.

Mr. Cottrell presented the following preamble and resolutions:

WHEREAS, Death has removed from our midst one of our most esteemed fellow citizens, and a former honored member of this body, Christian F. Schmidt, and whereas, the worth of Mr. Schmidt as a citizen, his pure and honorable conduct as a member of this body, renders it highly proper that this body express their sorrow at his death, and their respect for his memory. Therefore

Be it resolved, That the fair and honorable business life, the kind and liberal conduct as a citizen, the pure and honorable career as a public officer of Mr. Schmidt won for him the respect of all good citizens, and entitles his memory to high respect.

Resolved, That as an expression of our sorrow, and as a token of our high respect for the memory of Mr. Schmidt, we cause this hall to be draped in mourning for a period of thirty days, and that this Council and the city Police Force attend the funeral in a body, and that a copy of these resolutions be transmitted to the family of the deceased.

COMMON COUNCIL.

Mr. Craft, from same Committee, submitted the following miniority report:

INDIANAPOLIS, Feb. 5, 1872.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN-The undersigned, minority of the Committee on Contracts, to whom was referred the bids for paving the north, west and south sides of University square with Lefler or other cement paving stone, would report that we find four bids on the same, viz: One from Thomas Roney, at twenty cents per square foot; one from James Hudson, at twenty-four and a half cents; one from John T. Macauley, at thirty cents; and one from George Wendel, at thirtyone cents per square foot. And as there is an admitted difference in size and thickness of the stone proposed to be used by the different contractors, and as there is nothing said in the ordinance authorizing the work to be done in regard to size and thickness of the same, we are unable to decide which is the lowest and best bid under the ordinance, we therefore report the said bids back, and recommend that an ordinance of repeal be passed, and a new ordinance passed defining more explicitly the size, thickness and quality of stone to be used on said improvement.

By unanimous consent, the Committee of Citizens appointed at a meeting held in the Board of Trade rooms presented,. through W. P. Fishback, the following petition:

INDIANAPOLIS, February 5, 1872.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN—Your petitioners believe that the speedy construction of a railroad to the coal fields has become a necessity to our city, and that a cheap road by a practicable and direct route can be constructed, that will insure an abundant supply of fuel to our citizens, at rates far below those paid by the people of any other city in the west; to this end we ask your honorable body to make the necessary appropriation, and select a competent engineer for the immediatesurvey of thé cheapest and most practicable route.

Mr. Wiles offered the following resolution :

Resolved, That a Committee of three be appointed to act in conjunction with the citizens committee, in investigating the cost and propriety of the city constructing or aiding in the construction of a railroad from the coal mines to this city, and that said Committee of three be authorized to employ a competent engineer and assistants to make a survey and estimate of the cost of such road.

Mr. Brown moved to amend by instructing said Committee to enquire into the expediency of employing a competent engineer and assistants to make a preliminary survey for such road.

Which, on motion by Mr. Whitsit, was laid on the table.

Mr. Newman offered the following amendment:

That the Committee shall have power in their discretion to employ agents, one or more, whose duty it shall be to take leases of coal lands, in such places as it may be probable that such proposed road may terminate or rnn near, for the benefit of the city alone.

Which was adopted.

Mr. Kennington moved to amend by adding that the cost of making such survey shall not exceed \$1,500.

Which was not adopted.

The resolution as offered by Mr. Wiles, and amended by Mr. Newman, was then adopted by the following vote:

Affirmative—Councilmen Batty, Cottrell, Craft, Gimber, Heckman, Kennington, Locke, Marsee, Newman, Reagan, Thalman, Thoms, Weaver, Whitsit, Wiles and Woodburn—16.

Absent—Councilmen Bigham and Brown—2.

His Honor, the Mayor, appointed as such Special Committee, Councilmen Wiles, Heckman and Newman.

On motion, the Council adjourned.
