CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS,
Thursday, March 14, 1872, 7½ o'clock, P. M.

The Common Council met pursuant to adjournment.

Present—His Honor the Mayor, Daniel Macauley, in the chair, and the following members:

By unanimous consent, Mr. Newman introduced Special Appropriation Ordinance No. 19, 1872, entitled:

An Ordinance to provide for an appropriation to defray expenses of the Engineer and his corps now engaged in the survey of what is known as the Coal Railroad line.

Which was read the first and second times, and ordered engrossed.

Mr. Newman moved a suspension of the rules for the purpose of reading the ordinance the third time and placing it on its passage.

The question being, shall the rules be suspended?

GENTLEMEN—Your Committee on Gas Light beg leave to report, that under the existing instructions from Council, the Gas Inspector does not feel authorized to direct the lighting and extinguishing of the gas in the public lamps of the city in such manner as to light each post for more than two thousand hours during the year; and in as much as it is found to be impossible, under that limited "time table," to provide against cloudy nights at all times during the different changes of the moon, your Committee recommend that the Gas Inspector be allowed discretionary power in lighting said lamps, and that he be instructed to report, each month, the amount of gas consumed, in excess of the adopted "time table" for the present year.

Your Committee find upon consultation that in order to make said bridge safe and secure in the passage of stock and in the hand railing, a further expenditure of about (\$2,500) two thousand five hundred dollars will be necessary; we have, therefore, been requested to ask from the Common Council a further appropriation of one thousand dollars (\$1,000) to aid in this work, and upon the same conditions and restrictions as former appropriations.
