## REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, April 15, 1872, 7½ o'clock P. M.

The Common Council met in regular session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

The proceedings of the regular session held April 8th, 1872, were read and approved.

Sealed proposals were opened, read, and referred to the Committee on Contrats.

Mr. Craft, from the Committee on Contracts, submitted the following report:

## INDIANAPOLIS, April 15, 1872.

#### To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN—We the undersigned, members of Committee on Contracts, to whom was referred the bids on the Illinois street sewer, believing all things considered that the Indiana Cement Pipe company is the best bidder, would recommend that the contract be awarded to them at their bid on the same, viz: \$7.25 for four feet pipe, and \$6.90 for three and a half feet pipe; \$133.00 for catch basins, and \$40.00 for man holes, and we would further recommend that the house connections be dispensed with.

Mr. Marsee introduced General Ordinance No. 26, 1872, entitled :

An Ordinance to appropriate ground for an alley through the southwest half of square No. 101.

Which was read the first time.

Mr. Thalman, from the Committee on Streets and Alleys, made the following report :

INDIANAPOLIS, April 15, 1872.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN—Your Committee on Streets and Alleys, to whom you referred sundry papers, beg leave to report as follows:

1st. Is a petition asking for the passage of an ordinance to pave with brick the south sidewalk of Vermont streeet, between Illinois and Muskingum streets. We herewith introduce an ordinance for the improvement, and recommend its passage.

2d. Is a motion that the Marshal notify J. C. Furguson to remove the obstruction from the east sidewalk on South Pennsylvania street, between South and Merrill streets. The obstruction is a dilapidated platform, and should be removed; we recommend that the motion be concurred in.

3d. Is a petition from property owners on North West street asking permission to widen the sidewalks between North and St. Clair. We would recommend that they be granted permission to set out the curb five feet, leaving the street  $56\frac{2}{3}$  feet wide, which will correspond with the contemplated improvement on said street south.

4th. Is a remonstrance from property owners on the north side of St. Clair street, against the passage of an ordinance to pave and curb the sidewalks of said street between New Jersey and Deleware. We would recommend that the ordinance be amended by striking out "curbing," and then passed.

5th. Is a petition from property owners on West Washington street, west of the river, asking for the widening of said street. We recommend that the petition and plat be referred to the City Commissioners.

6th. Is a petition from property owners on North New Jersey street, asking that J. W. Brown and others be ordered to set back their fence on a line with the sidewalk, same as is on either side of their property. We would recommend that the petition be referred to the City Commissioners for action.

7th. Is a remonstrance from property owners on Forest avenue praying against the passage of an ordinance to grade and gravel said street, between Cedar street and Corporation line. As the street needs improving we would recommend that the ordinance be passed.

8th. Is a petition from D. Willig and E. H. and M. Griffith property holders on St. Marys street, between Alabama street and Western avenue, praying that they be permitted to grade and pave with brick the sidewalk in front of their property; also that they be paid for dirt placed on said street by them. We would recommend that permission be granted to paye their sidewalks at their own expense, under the direction of the Civil Engineer; and that no allowance be made for the dirt placed on said street.

9th. A motion that the alley running north and south, in tl rear of lots 1, 2, 3, 4, and 5, in Pope's subdivision of the south onhalf of lot 1, in St Clair's addition; also the alley on the south sic of lot 1 in said subdivision, be ordered to be opened within thirt days. As the alley is fenced in we recommend that the Marsh; give the required notice.

GENTLEMEN—Your committee on streets and alleys to whom wa referred the petition of Samuel Merrill and others asking for th vacation of a 16 foot alley, running from the south to the north linof lot 24, in the sub-division of the north-east quarter of section 36 town 16, north of range 3 east, made by the Commissioner in the partition of the estate of Thomas Johnson among his heirs; said alley passing along the line dividing the east four-tenths from the west six-tenths of said lot 24, beg leave to report:

That we have examined the subject matter of the petition, and the notice, publication, proofs and proceedings in the matter, and fine them regular in form and sufficient in law. We find the petitioner, to be the owners of the lots fronting on said alley, and that no remon strance has been filed against said vacation. We believe that if an alley be opened further east, as is proposed, it will be of more gen eral use, and be more in accordance with neighboring alleys than the present one.

#### to the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN—The undersigned parties would respectfully state to our honorable body that they are the sole owners of the real estate hereafter mentioned, to-wit: The said Samuel Merrill is the owner in ee of the east four-tenths of lot 24 in the Commissioners subdivision of the north-east quarter of section 36, town 16, north of range 3 east, commonly known as Johnson's heirs' addition to the city of Indianapolis. Mrs. Mary Poor is the sole owner in fee of lot No. 18. Aaron Clem is the sole owner in fee of lot No. 19, and J. Perry Elliott is the sole owner in fee of lot No. 28, all of said last named ots being in Phillips subdivision of the west six-tenths of said lot 24 in Johnson's heirs' addition aforesaid.
