

SPECIAL MEETING

Tuesday, January 1, 1952 12:30 o'clock P. M.

The Common Council of the City of Indianapolis met in the Council Chamber at the City Hall, Tuesday, January 1, 1952, at 12:30 P. M., with Grace M. Tanner, City Clerk, acting as temporary Chairman, pursuant to the following call:

TO THE MEMBERS OF THE COMMON COUNCIL, INDIANAPOLIS, INDIANA.

You are hereby notified that there will be a SPECIAL MEETING of the COMMON COUNCIL held in the Council Chamber on January 1, 1952 at 12:30 o'clock P. M. the purpose of such SPECIAL MEETING being to elect officers of the Common Council of the City of Indianapolis for the year 1952, who shall serve until the first Monday of January, 1953; and appointment of the Council's Standing Committees, pursuant to the laws of the State of Indiana as contained in Section 48-1403, Burns R. S. 1933.

The Chairman called the meeting to order.

The Deputy Clerk called the roll.

Present: Mr. Bright, Mr. Brown, Mr. Ehlers, Mr. Eltzroth, Mr. Emhardt, Mr. Radel, Mr. Ross, Mr. Schumacher, Mr. Wicker.

The Chairman announced the first order of business to be the election of officers for the year 1952, and asked for nominations for the office of President of the Council.

Mr. Eltzroth made a motion to nominate Mr. Bright. The motion was seconded by Mr. Ross and a motion was made by Mr. Brown and seconded by Mr. Radel that the nominations be closed and the Clerk instructed to cast the unanimous vote of those present for Mr. Bright. The vote was cast as directed and the Chairman announced the election of Mr. Bright as President of the Council for the year 1952. On invitation of Mrs. Tanner, Mr. Bright took the chair.

President Bright asked for nominations for the office of Vice-President. Mr. Brown nominated Mr. Schu-

macher. The nomination was seconded by Mr. Radel. Mr. Ehlers moved that nominations be closed and the Clerk instructed to cast a unanimous vote for Mr. Schumacher and the same was seconded by Mr. Eltzroth. The vote was cast as directed and President Bright announced the election of Mr. Schumacher as Vice-President by the unanimous vote of the Council.
