The Committee on Markets and City Attorney, through Councilman McGroarty, submitted the following report amending G. O. 2, 1887:

To the Mayor and Common Council:

Gentlemen:—The undersigned, Market Committee and City Attorney, to whom was referred G. O. No. 2, 1887, respectfully report that we have examined the same, and recommend that Section 5 of said ordinance be amended so as to read as follows:

SECTION 5. Said Market Master shall be the custodian of all buildings connected with said market, including Tomlinson Hall. And it is hereby made his duty to have charge of the opening, lighting, heating, cleaning, repairing and closing of all of said buildings, and to see that order is maintained during all meetings in said Tomlinson Hall, and to preserve order and strict discipline in and around all the buildings on said market space. All janitors, assistant janitors and laborers in or around said buildings or market space, shall be subject to the order of the Market Master. He shall have full and exclusive charge and control of the market under said Hall, and the meat market east thereof, and of the entire market space, and of all stands that may at any time be permitted outside of said buildings connected with the said market, and of all persons permitted in this ordinance to sell any article from their wagons in, or around, said market space, with full power to enforce the provisions herein contained. He shall see that the market houses, the market space, and all the surroundings, are cleaned up after every market; and to this end he shall require every butcher and marketer to carry away with him all refuse matter collected in or about his stall, stand or wagon. Any butcher or marketer neglecting or refusing to clean up immediately after the close of market hours, as directed by the Market Master, shall pay to said Market Master the reasonable cost of having said work done, before he shall again be permitted to occupy any stall, or stand on said market. Any violation of this requirement on the part of any butcher or marketer, shall work a forfeiture of any money already paid by him as rent for said stall, stand or place.

And when so amended, that said ordinance pass. Respectfully submitted,

O. 2, 1887—An ordinance supplemental to the ordinances of the City of Indianapolis, on the subject of the General Markets of said city; modifying and changing certain Rules heretofore existing for the regulation and management of said markets; repealing all conflicting provisions: putting Market Masters on salaries; requiring that all rents and fees of marketers shall be paid into the treasury.

Councilman Dunn, on behalf of the Committee on Streets and Alleys, reported that the petitioners in the matter of opening a street on the line of an alley between Georgia and Louisiana streets, from Meridian street to the first alley west of, and parallel to, Meridian street, desired to with draw their petition in the matter.

On motion by Councilman Cummings, permission was granted, and the petition was withdrawn.

Councilman Dunn, in behalf of the Committee on Streets and Alleys, •submitted the following report; which was referred back to the same committee :

To the Mayor and Common Council:

Gentlemen:—Your Committee on Streets and Alleys, to whom was referred the petition of John Faehr, William H. English, Yandes and Malott, and others. pray-ing for the widening of so much of the alley lying between Meridian and Illinois streets as lies south of the south line of Georgia street, and the north line of the first alley south of said Georgia street, in the City of Indianapolis, to the width of fifty (50) feet, and that all the ground necessary for the purpose of increasing the width of said alley, namely, a strip of ground thirty five (35) feet in width, to be wholly taken from the real estate abutting on the west side of said alley petitioned to be widened, report that having examined said petition and the premises, recommend that the prayer of the petitioners be granted, and that the resolution accompanying this report be adopted.

Resolved by the Common Council and Board of Aldermen of the City of Indianapolis, That the petition of John Fachr, William H. English, Yandes and Malott, and others, praying that so much of the alley lying between Meridian and Illinois streets, in the City of Indianapolis, as lies south of the south line of Georgia street, and the north line of the first alley south of said Georgia street, be widened to the width of fifty (50) feet, and that all the ground necessary for the purpose of increasing the width of said alley, namely, a strip of ground thirty five (35) feet in width, shall be wholly taken from the real estate abutting on the west side of said part of said alley so petitioned to be widened, be referred to the Board of City Commis-sioners, with instructions to assess benefits and damages, and to make due report to the Common Council and Board of Aldermen; the Commissioners to return all petitions and notices. The City Clerk is hereby instructed to issue the proper no-tices, and the Superintendent of the Metropolitan Police Force is hereby directed to serve said notices upon the said Board of City Commissioners and upon the property owners interested in said widening : Provided, That before the Clerk issue the said notices to the City Commissioners, a bond shall be filed with said City Clerk to the approval of the Mayor, guaranteeing the payment of all costs and charges of said Commissioners in this matter.

Councilman Thalman presented the following remonstrances relative to the above; which were referred to the Committee on Streets and Alleys:

To the Honorable, the City Council of Indianapolis:

Gentlemen:-The undersigned, citizens of the City of Indianapolis, and owners of property on south Meridian street, between Washington and Louisiana streets, re-spectfully represent to your honorable body that they are informed that a petition has been presented for your consideration and action, to open a street fifty feet wide, running north from the center of Square 87, along the alley between Illinois and Meridian streets, to the south line of Georgia street, being a distance of about two hundred feet. The undersigned believe that such a street would detract from the value of their property on Meridian street, and Louisiana street and its exten-sion, by diverting travel from the same, and by furnishing a large amount of rival business property, and therefore represent that they are opposed to opening such street, and hereby respectfully remonstrate against the favorable consideration of such petition by your honorable body. To the Mayor, Common Council and Board of Aldermen of the City of Indianapolis :

Gentlemen:-The undersigned, owners of realty known as Numbers 21, 23 and 25, west Georgia street, respectfully remonstrates against the passage of the ordinance providing for the widening of the alley west of his premises, and the opening of a fifty foot street thereon, to run south from Georgia street along said alley to the Union Depot, for these reasons: The above mentioned real estate being forty-one feet front on Georgia street, and ninety five feet on the alley, has not sufficient depth to make the alley front of any value. The building has been built and equipped as a steam bakery, with ovens and other plant, costing much time, labor and expense, and arranged with chutes and elevators on the alley side for despatching: the business of the bakery, which would be seriously hindered by placing a wide sidewalk, suitable for the proposed street, on the alley adjoining the west side of said bullding. The present tenants and the petitioner incurred all of these expenses long before the questions concerning the new depot were raised, and did so in the full expectation that they would be permitted to enjoy the undisturbed possession of the property until their business profits would cover the cost of the plant, and a fair reward for their labor; and as they are receiving and discharging materials in his alley for fully one-half of the business hours of the day, their business would be obstructed materially by the passing and re-passing of persons to and from the de-pot. Your petitioner is of the opinion, and has been informed, that the Union Railway Company have provided sufficient means for the ingress and exit of per-sons doing business at the Union Depot, and for that reason the opening of this street is unnecessary. While it is true that the lots running from Illinois and Meridian streets, and terminating on this alley, and which are at present unimproved, might be benefited by the opening of such a street, giving them a double frontage, it is also true that this petitioner has no interest in such property, and would derive no benefit from such improvement; and having built and established his business-without their aid, he would prefer to have matters remain as they are; and if changed, that it should be done at the proper expense of those who expect to realize a reward for their undertaking. INTRODUCTION OF MISCELLANEOUS BUSINESS.

That Mr. Caughflin, on Indiana avenue, be notified to repair the brick sidewalk in front of his property within twenty days, or if he fails to do the same, that the Street Commissioner do the same at the expense of said owner.

Councilman Dell offered the following motion; which was adopted:

That Rodgers Brothers be, and are hereby, granted permission to lay two double stone crossings (with the necessary bowldering) driveways across the sidewalk in front of their place of business, south side of Washington street, between Noble and Benton streets, at their own expense, under the direction of the City Civil Enginer.

Councilman Herig presented the following petition; which was referred to the Committee on Streets and Alieys:

To the Mayor, 'Common Council and Board of Aldermen of the City of Indianapolis:

Gentlemen:—The undersigned, owners of real estate in the vicinity of the street hereinafter proposed to be opened and widened, respectfully petition your honorable bodies to open and widen to the width of fifty (50) feet, a street located and described as follows. Commencing at the south line of Georgia street, one hundred and ninety-five feet east of the east line of Meridian street; thence south parallel with the east line of Meridian street to a point on the north line of South s.reet one hundred and ninety-five feet east of the east line of Meridian street; thence east fifty feet; thence north parallel with the east line of Meridian street to the south line of Georgia street; thence west fifty feet to the place of beginning. Councilman Reinecke offered the following motion; which was adopted:

That the Street Commissioner be directed to place a crossing of broken stone across Beaty street at the first alley north of Buchanan street, east side of Beaty street, said street being 775 feet long without a crossing.

Councilman Smither, for Councilman Rooker, presented the following petition; which was referred to the Committee on Streets and Alleys:

Indianapolis, Ind., February 15th, 1887.

To the Members of the Common Council and Board of Aldermen :

Gentlemen:—We, the undersigned, citizens of Indianapolis, living upon and owning property in Henderson's addition to said city, petition and ask that you will open an alley, commencing at Ninth or Williams street, between Tennessee and Mississippi streets, thence running south four hundred and forty feet to the north line of the Base Ball Park. We desire the alley to be twelve feet wide. A plat of

Gentlemen:—The undersigned petitioners, owning the real estate adjoining the four sides of the real estate sought to be vacated, as hereinafter set forth, respectfully represent and show to your honorable bodies that Fifth street fronting east on Meridian street, in the City of Indianapolis, Indiana, runs west from said Meridian street a uniform width of twenty (20) feet until it reaches a point in said street about one hundred and nine and a half $(109\frac{1}{2})$ feet west of Illinois street, when, by the accession of ground on the north side thereof, said Fifth street widens to about seventy-one (71) feet, so that on Illinois street, fronting west, said Fifth street is about seventy-one (71) feet wide.

Your petitioners show that said Fifth street, in excess of twenty (20) feet, fronting on Illinois street, is not used, except as a place to dump refuse, and is therefore detrimental to the surrounding property. Your petitioners believe that it would be to the best interest of said city to vacate so much of said Fifth street as lies east of Illinois street, that is to say: Commencing at a point on the north line of Fifth street, where it intersects Illinois street; thence running south on the east line of Illinois street about fifty-one (51) feet; thence east through Fifth street about one hundred and nine and a half $(109\frac{1}{2})$ feet; thence north about fifty-one (51) feet; thence west about one hundred and nine and a half $(109\frac{1}{2})$ feet to the place of beginning—containing about fifty-one (51) feet fronting west on Illinois street, and running thence east a uniform width about fifty-one (51) feet, to a point about one hundred and nine and a half $(109\frac{1}{2})$ feet, leaving Fifth street a uniform width of twenty (20) feet from Illinois the Meridian street.

Your petitioners show that the undersigned, Geo. W. Snider, owns the real estate fronting on Illinois street, immediately north of, and adjoining that part of Fifth street which your petitioners pray may be vacated; and they submit herewith a plat of the ground and surroundings, showing the metes and bounds, and they pray that your honorable bodies will cause the same to be referred to the Committee on Streets and Alleys for investigation and report; and they will ever pray.
