The City Civil Engineer submitted the following report; which was referred to the Committee on Railroads, City Attorney and City Civil Engineer:

To the Mayor, Common Council, and Board of Aldermen:

Gentlemen:—Under your instructions, I gave notice to fifteen bridge companies that I would, on the 30th day of April, 1887, receive proposals for re-constructing the Illinois street tunnel. In answer to said notice, I received five bids, which were as follows:

As will appear at a glance, all bids for the tunnel complete, are in excess of the amount of the appropriation; therefore I refused to award the contract.

In this connection I desire to say that the estimated cost of the tunnel complete, as made by F. C. Doran, Engineer of The Indianapolis Union Railway Company, and myself, was \$27,558.66. To this amount was added, for contingencies, the sum of \$2,441.34—making a total of \$30,000.00.

On inquiring of the bidders, as to the cause of the extraordinarily high bidding,

they were practically unanimous in saying that it was owing to their inability to obtain from Mr. Doran, Engineer of The Indianapolis Union Railway Company, any definite idea as to what he, under the provisions of the specifications, would require for the supporting of the several tracks of the Union Railway Company. And further, that Mr. Doran stated that in addition to the tracks now on said street, he would have seven (7) more, over the tunnel to support by the time the tunnel was ready to be improved.

As to whether or not Mr. Doran made the statements above referred to, I do not know; but as to the bidders having so informed me, the Mayor, City Attorney and Councilman Haugh, who were present, can testify. It is, however, due to Mr. Doran to say that he has since denied, to me, the statements made by the bidders.

I submit the above for your information, and await your further orders.

Councilman Howes offered the following motion; which failed of adoption:

That the Railroad Committee, with the City Attorney and City Civil Engineer' to whom was referred the letting of the tunnel contract, have power to act in the premises.

The City Attorney submitted the following report; which was received :

To the Mayor and Common Council:

Gentlemen:—In answer to sundry matters referred to me, I report thereon as follows:

1st. As to the legality of Special Ordinance No, 168, 1886, providing for the construction of a four-foot circular brick sewer in and along Ray and Rockwood streets, from the present terminus of the sewer in Ray street at Pogue's Run, to the east bluff of White River, I will answer as follows: The forty-third clause of Section 3106, R. S. 1881, contains the original charter provisions for the construction and payment therefor for sewers in general. Doubtless under the provisions of this clause, a majority vote would probably be all that would be necessary in the passage of such an ordinance. This Act was passed in 1867, but in 1881 the Legislature passed a supplemental Act upon this subject, which provides, that when in the opinion of the Common Council the construction of any sever will be a public benefit to the city, and necessary for the improvement of any street or streets for the removal of any surface or storm water thereform, may, by a two-thirds vote, cause to be paid out of the city treasury such portion of the cost of the construction of the sever as the Council deems just and equitable. (See Sec. 3151, 1886.)

The sewer system of this city, unlike that of many other cities, is a combination system of sewerage used for the double purpose of carrying off storm water and sewage; and this being the case with the sewer in question, a two thirds vote is necessary for the passage of this ordinance.

In 1881 the Legislature passed still another sewer act, providing for the dividing of cities into sewer districts, and for the levying of a special sewer tax, and the paying for all sewers out of the public funds. This act would have required simply a majority vote, but it was repealed by the Act of 1885, leaving the two Sections above referred to as the only law upon this subject. Therefore, the ordinance in question, not having been passed by such two thirds vote, has not been legally ordained.

2d. This question is submitted: "Has the Council the power to create and enforce an ordinance compelling residents on streets to sprinkle the same and pay *pro rata* per foot front, where a majority petit on for the same?"

To this question there can be but one answer, and that is in the negative. The right to take property for street improvements or for any other purpose, by the city, is the highest prerogative of a municipal government, and is never exercised except by Legislative enactment, and that within constitutional provisions; and those cities that exircise this right, exercise it by virtue of charter provisions granted to them by the Legislatures of their respective States. The only way in which the streets of this city can be sprinkled under the law and ordinances now in force, would be to pay for the same out of the public revenues

I might add in passing, that I prepared a bill, giving to this city the power possessed by many other cities, of compelling property holders to sprinkle the streets in front of their property, and creating a lien thereon, similar to that given for street improvements, and but for the dead-lock, would probably have secured its passage through the last Legislature.

Gentlemen:—Your Committee on Streets and Alleys, with the City Attorney and City Civil Engineer, to whom was referred Special Ordinance No. 69, 1887, providing for the improvement of Washington street, report that we recommend the following amendments to Section 1 of said ordinance:

1st. By inserting after the words "pitch bitumen," in line 4, page 3, these words : "Mixed with not less than ten per cent. of refined Trinidad asphaltum."

2d. After the word "sidewalks," in line 9, page 3, the words "where not already properly done."

3d. By striking out in line 10, page 3, the words "or Berea sand stone."

4th. By striking out of line 11, page 3, the word "three," and substituting in lieu thereof, the word "four."

5th. By striking out of line 11, page 3, the word "thirty-six," and substituting in lieu thereof, the word "twenty-eight."

6th. By striking out of line 11, page 3, the word "six," and substituting in lieu thereof, the word "five."

And when so amended, we recommend said ordinance pass.

In view of the recent order of the Indiana State Board of Health, all persons connected with the Indianapolis Board of Health must flag all buildings where small pox, cholera, scarlet fever, diptheria and measels exist, and if there are cases unreported or unattended by a physician, require the householder or some member of the family [or the Sanitary officer himself], to report such cases as are within their knowledge. While it is not intended to make any health order obnoxious or unreasonable to any fair-minded person, yet the severe nature of these diseases at this time, and especially the frequent returns of death from measels or some of its complications, has created a demand from the physicians and people at large, that these rules must be rigidly enforced, and if necessary, resort to the law as a means of compulsion. *Resolved*, That it is the belief of this body, that if the citizens of Indianapolis would advance a sum equivalent to one half  $(\frac{1}{2})$  of the amount annually paid by them for fuel, that a fund could be raised that would be sufficient to obtain a supply of natural gas that would give free fuel to the entire city; therefore, be it further

*Resolved*. That the business men and all other citizens, be given an opportunity to secure these benefits for themselves, before we grant them to others; and to that end we unite in calling a mass meeting of citizens, to be held in Tomlinson Hall, Friday, May 6th, at 7:30, P. M., to discuss the feasibility and propriety of securing free fuel for all.

Councilman Pearson offered the following motion relative to the above:

That all natural gas ordinances be referred to a special committee of five, to which shall be added the Mayor, City Attorney and City Civil Engineer, they to report back the ordinances and recommendations at the next regular meeting.

Councilman Swain offered the following as a substitute for the above motion; which was adopted:
