REGULAR SESSION—JULY 25, 1887.

The Board of Aldermen of the City of Indianapolis, met in the Aldermanic Chamber, Monday evening, July 25th, A. D. 1887, at eight o'clock, in regular session.

PRESENT-Hon. Thomas E. Endly, President of the Board of Aldermen, in the Chair, and Aldermen Crosby, King, Laut, Prier, Pritchard, Rail, Schmidt, and Wright-9.

ABSENT, 1-viz: Alderman Brown.

The Proceedings of the Board of Aldermen for the regular session held July 11th, 1887, having been printed and placed on the desks of the Aldermen, said Journals were approved as published.

MESSAGES AND PAPERS FROM THE COMMON COUNCIL.

The report from the City Attorney and City Clerk, on Sellers Farm, (see pages 474 and 475, *ante*), was read, and the favorable action of the Common Council thereon, was concurred in.

The semi-annual report of the Chief Fire Engineer (see 477, ante), was read and received.

The report from the Board of Public Improvements and Street Commissioner, showing expense of Street Repair Department for the month of June, 1887, (see pages 477 and 478, *ante*), was read and received.

The following report from the Board of Public Improvements (see page 478, *ante*), was read, and the favorable action of the Common Council thereon, was concurred in :

To the Mayor, Common Council and Board of Aldermen :

Gentlemen:—The Board of Public Improvements, to whom sundry papers were referred, would report thereon as follows:

1st Is a motion that the Street Commissioner clean Washington street, and repair the same with broken stone, from Noble street to Reid street.

Recommend the work be done.

2d. To repair the approaches to Arsenal avenue, on Ohio street.

Recommend the work be done.

3d. To repair the first alley crossing the sidewalk on Pine street, south of Michigan street, on the west side. Recommend the work be done.

4th. To repair the brick sidewalk at the northeast corner of Railroad and Michigan streets. Recommend the work be done.

5th. To fill the chuck holes at the corner of Archer and Michigan streets.

Recommend the work be done.

6th. To clean the gutters on Indiana avenue, from North street to Fall Creek. Recommend the work be done.

7th. To fill all the chuck holes on Indiana avenue, from North street to Fall Creek, with broken stone. Recommend the work be done.

The report of the Board of City Commissioners in the matter of widening the alley through the middle of the north one-half of Square 87, City of Indianapolis, and the following resolution relative thereto, (see pages 479 to 484, *ante*), were read;

Resolved by the Common Council and Board of Aldermen of the City of Indianapolis Indiana, That the report of the Board of City Commissioners in the matter of widening to a width of fifty feet so much of the alley lying between Meridian and Illinois streets as lies south of the south line of Georgia street and north of the first alley south of Georgia street; all in the City of Indianapolis, Marion County, Indiana, as described in said report of the Board of City Commissioners, be, and the same is hereby in all things accepted, adopted, and approved. And in accordonce with said report the parcels of land specifically described in said report, to-wit:

Thirty-five (35) feet off of the east end of Lot twelve (12), in Square eightyseven (87), known as Lot one (1) and five (5) feet off of the east side of Lot two (2) in Mothershead's heirs' subdivision of Lot twelve (12) in Square eighty-seven (87).

Also, thirty-five (35) feet off of the east end of Lot eleven (11) in Square eightyseven (87).

Also, thirty five (35) feet off of the east end of the north half of Lot ten (10) in Square eighty-seven (87.) Also, thirty-five (35) feet off of the east end of the south half of Lot ten (10) in Square eighty-seven (87.)

All being in the City of Indianapolis, Marion County, Indiana, be and the same are hereby appropriated, and the damages awarded, with the benefits assessed, by said Board of Commissioners in this matter are hereby in all things approved and confirmed.

Resolved further, That the parties against whom benefits are assessed in said report be, and they are hereby ordered to pay to the Treasurer for the city the amount of benefits assessed over the damages by reason of such widening.

And that the City Clerk be directed to deliver a certified copy of so much of said report of the Board of City Commissioners as assesses benefits and damages upon real estate, and in which the real estate so assessed is described, with the owners thereof, to the Treasurer for the city; and to copy the entire report of said City Commissioners into the records of the Common Council, and to file and preserve the original.

Provided, That before said street is opened to the public, or any damages are paid, all of the benefits awarded in their said report shall be paid into the city treasury, and no person shall be paid any damages until he shall have removed all the buildings on said proposed street.

Provided, further, That the City Clerk be, and he is hereby, instructed to make out and have recorded in the office of the Recorder of Marion County, Indiana, the proper certified copy of proceedings and plat as required by law.

And the favorable action of the Common Council thereon was concurred in, and the resolution concurrently adopted, by the following vote :

The report of the Committee on Railroads and City Attorney, on the communication of A. W. Johnson, President of the Citizens' Street Railway Company, (see pages 486 and 487, *ante*), was read, and the favorable action of the Common Council thereon, concurred in.

The following motions (see pages 491 and 493, *ante*), were read, and the action of the Common Council, in referring them to the Board of Public Improvements, with power to act, was concurred in :

That the Street Commissioner be instructed to repair the gutters on the south side of Massachusetts avenue, between Liberty and Noble streets.

That the Street Commissioner' be instructed to clean the gutters on north West street, between North and Sixth streets, and Blake street, on the east side, between Indiana avenue and North streets. The following motions (see pages 491 and 492, *ante*), were read and concurrently adopted:

That the Street Commissioner be, and is hereby, instructed to fill the chuck-holes on Noble street, between North and New York streets.

That the Street Commissioner be, and is hereby, instructed to clean the gutters on Liberty street, between North and New York streets.

That the Street Commissioner be directed to repair the crossing of Chesapeake and the west side of Pennsylvania street, as the same is now dangerous to teamsters that have to drive there.

Resolved by the Common Council and Board of Aldermen of the City of Indianapolis, That the accompanying first and final estimate in behalf of Freaney Brothers, for erecting two lamp posts, lamps and fixtures (complete to burn gas, except the service.pipes), on Gregg s reet, between New Jersey and East streets, be, and the same is hereby, adopted as the estimate of the Common Council and Board of Aldermen of said city; and that the property owners are hereby required to pay the sums set opposite their respective names.

And it was concurrently adopted by the following vote:

The report from the City Civil Engineer, relative to the contract of Henry Clay, to improve Dorman street (see page 514, *ante*), was read and rec eived.

The following motion relative to the foregoing subject (see page 514, *ante*), was read and concurrently adopted :

That the City Civil Engineer be insiructed to re advertise for bids for the improvement of Dorman street, from Michigan street to St. Clair street; the expense of said advertisement to be paid by Henry Clay, said Clay having failed to file his bond in proper time.

The following report from the City Civil Engineer (see pages 514 and 515, *ante*), was read:

To the Mayor, Common Council and Board of Aaldermeu:

Gentlemen:—On June 6th and 13th, 1887, the report of the City Commissioners in the matter of opening the street commonly known as "Viaduct street," was concurred in and adopted, since which time everything has been ready, as far as is required by the city, for the erection of the Union Railway viaduct.

I am in'ormed by V. T. Malott, Vice-President and Manager of said company, that the amount of damages which said Union Railway Company should pay for the condemnation of the right-of-way, is, and has been for some time, ready to be paid into the treasury.

since the adoption of the report of the City Commissioners, however, four parties, to wit: Frank M. Dell, William Dell, G. R. Root and Peter F. Bryce, have filed appeal bonds. I am imformed by V. T. Malott, Esq., that, were it not for the appeals, the Union Railway Company are ready and willing to proceed with the erection of the viaduct and to pay all damages assessed against said company by reason of said opening, but that he thinks the work of erection will be delayed in consequence thereof. I beg leave to inform you that a delay until the cases can be heard on an appeal, will simply mean that the viaduct will not be built this year. Respectfully submitted.

That the Street Commissioner be, and is hereby, instructed to fill up the chuck holes on New York street, from Douglass street to Agnes street.

That the Street Commissioner be directed to place a culvert over the gutter on the east side of Meridian street at Merill street.

That the Street Commissioner be directed to clean the well and place therein a Howe rotary pump, located at 190 East Washington street. The following entitled ordinance (passed by the Common Council) was read the first time:

Ap. O. 41, 1887—An ordinance appropriating money for the payment of a certain claim against the City of Indianapolis, on account of Tomlinson Hall. [Amount appropriated, \$90.40.]

On motion by Alderman King, the Rules were suspended for the purpose of placing the foregoing entitled ordinance on its final passage, by the following vote:

19th. On Delaware street, from the southwest corner of Maryland street to northeast corner.

Recommend the work be 1 of done.

21st. On Michigan street, east side of Blackford street.

Recommend the work be not done.

That the Street Commissioner be, and is hereby, ordered to lay stone crossings across the alleys on Linden Street, from Prospect street to Orange street.

That the Street Commissioner be, and is hereby, ordered to lay stone crossings across the alleys on the east side of Shelby street, from Prospect street to Pleasant Run. That the Street Commissioner be, and is hereby, ordered to lay stone crossings across the alleys on the north side of Woodlawn avenne, from Dillon street to Reid streets.

That the Street Commissioner be, and is hereby, ordered to lay double stone crossings across Woodlawn avenue on the west side of Linden street; also, double stone crossings across Linden street, on the south side of Woodlawn avenue, being the approaches to Edwin Ray M. E. Church.

That the City Civil Engineer be, and is hereby, instructed to direct the Street Commissioner to provide an increased capacity of sewer for carrying off the water from the gutter on North Alabama street into the State Ditch.

M. in the restaurant space, said restaurant; and the City Clerk is hereby ordered to execute to the highest bidder at such sale, a lease therefor on the same terms that the other leases to the stands and spaces in and about the East Market space have been made: *Provided*, That no bid less than \$500.00 be received.
