OPENING AND REFERRING SEALED PROPOSALS FOR PUBLIC IMPROVE-MENTS.

Sealed proposals for the following street improvements were opened, read, and referred to the Committee on Contracts:

(S. O. 32, 1887)—For grading and paving with brick, the sidewalks of Summit street, from Washington street to the C., St. L. & P. R. R. tracks.

(S. O. 54, 1887) – For grading and graveling the first alley west of California street, from St. Clair street to Pratt street.

(S. O. 86, 1887)—For grading and graveling the roadway and paving with brick the sidewalks of Benton street, from Louisiana street to Bates street.

To His Honor, the Mayor, Members of the Council and Board of Aldermen:

Gentlemen:-We have in our Department three old Engines, one having been condemned for the past five years, and worthless, except for scrap. The other two, purchased in 1874, are very large and heavy-weighing in excess of 8,000 pounds. One of these, the No 6, at a recent fire burst her pump coil, which, to repair, would require being shipped to the builders, at Cincinnati, and will cost from \$1,000 to \$1,500 besides the freight each way, and still would be an old Engine, with an old boiler, liable to give out at any time. The other one, the No. 7, is not reliable, the boiler showing signs of weakness, and in all probability will require a general over-hauling and extensive repairs at an early date. These Engines, even if in good condition, are almost a dead letter, on account of their great weight Having but six Engines with which to cover our large districts, such large Engines are practically of but little benefit to us, except in their immediate vicinity. I think, on account of the weight, age and condition of these Engines, it would be policy to exchange them for one second size Engine, much lighter, and of equal capacity, thereby increasing the efficiency of that branch of our Department, and getting rid

Gentlemen:—Said W. F. Born respectfully represents to the City Council, that he is the sole owner of Lots 11 to 20, inclusive, in Terry & Robinson's subdivision in Out-lot 127, the said lots lying just north of Catharine street, 1823 feet from south to north, and extending 428 feet east and west, between West street and Missouri street. Plat 2 on the next page shows the plan of the original lots (11-20), and plat 1 shows the proposed plan of the new subdivision.

The lots of the old subdivision run lengthways north and south, whereas they ought to front on West street and Missouri street, as far as practicable, and this is now the case with the adjacent property. The dotted lines in plat 1 show the position of the present streets and alleys opposite to the lots 11-20. It will be seen

that they do not correspond to the original alleys of plat 2; in fact, the subdivision of the adjacent property is altogether different from the original plat. The length east and west is only eight feet more than that of the central squares of the city, and therefore no new north and south street is needed; and instead of one north and south alley, two are given. All of the lots in the proposed new subdivision are accessible both in front and rear, and being small in size, will sell more readily to people of moderate means than the old larger size lots. The property is owned by the undersigned alone, and the change can not affect any one injuriously.

Your petitioner respectfully asks permission to change the old subdivision, and to substitute the proposed new subdivision, as shown in plat No. 1.
