

GENTLEMEN: -- We, the undersigned, members of the Special Committee on Steam Road Roller, would respectfully report that we have given the matter a careful and personal investigation, three of your committee having visited Eastern cities where they are in use, and having seen the Rollers at work, as well as the streets made by them, would report that we are fully persuaded that the Steam Road Roller would be a great saving in making our sts, not only in the point of making, but on the point of economy and durability, which in our city is very desirable. We would further report that we find two classes of Steam road rollers in the market—the Aveling & Porter and the Secor roller, the first of English and the latter of American manufacture. We are fully satisfied that in many respects the Secor Roller is the best, being constructed exclusively of wrought iron; but those who are now using the English Roller in Eastern cities say they have given entire satisfaction, and having taken into consideration the importance of having better streets in our city, we, the undersigned, your committee, would recommend that the City of Indianapolis purchase a Steam Road Roller at once, and would recommend the American Roller as being preferable to the English Roller, on account of it being constructed of wrought iron, but as there is a difference in price of about one thousand dollars, we would recommend that only one be purchased, and leave it to the Council to determine as to the Roller they will select.

Dear Sir:-We propose to build a steam road roller for the City of Indi-

anapolis, to weigh not less than 30,000 lbs.

Main rollers to be 7 feet diameter by 5 feet wide; front rollers to be 4 feet diameter by 31 feet wide, both rollers to be made of boiler iron, riveted with countersunk rivets, and to have boiler iron heads.

The roller is to be driven by two engines, with cranks working at right angles: cylinders to be 9 inches diameter by 10 inches stroke, with all parts extra heavy.

Engines to be supplied with steam from an upright boiler of sufficient

capacity, which is to be made in the most substantial manner, and is to be furnished with steam guage, guage cocks, locomotive safety-valve, &c.

The engines will be geared directly into main roller, and both pinion and rack are to be made of cast steel. The gearing is to be protected by a sheet iron shield.

The boiler is to be felted and covered with Russia iron, secured with brass bands; the cylinders to be covered with sheet brass.

The roller will be furnished complete with steam pump, water tank, exhaust tank, &c., and all necessary oil cups on main journals and slides.

The roller is to be first class in every respect and ready for use before

leaving the works. ..., We will also furnish one spare pinion and one segment of rack, and deliver the roller complete on our wharf for the sum of seven thousand (\$7,000) dollars.

Indianapolis, May 21, 1872.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—The undersigned, owners of the real estate fronting on New Jersey street, between Washington and South streets, respectfully remonstrate against the passage of an ordinance to lay a railroad track across New Jersey street, between Pogue's Run and Washington street, for the following reasons: 1st. That the street is now almost continually blockaded with cars, and a passage over it is almost impossible. Reason Second: That no practical good can result from the passage of said ordinance to any of the property holders on said street, neither to the par-

ties asking for the passage of said ordinance, except their own convenience, and the said builing has been occupied by other parties to its fullest extent for several years, and they never asked for said privilege; and further that the capacities of said building could not be increased if desired.
