The City Commissioners made the following report:

INDIANAPOLIS, August 19, 1872.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN:—The City Commissioners have acted on the petition of the property holders on John street asking the widening of said street from 40 feet to 60 feet, from the first alley east of Peru, or Railroad street, and the donation line, which petition was referred to us by your honorable body.

According to the accompanying plat, which is the one furnished us, the proposed widening will take 10 feet off the north ends of lots 26, 27, 28, 29, and 30, and 10 feet off the south ends of lots 34, 35, 36 and 37, in Stumph's subdivision of out-lot 44. It also takes all of lot 75, except 3 feet off the south side, and all of lot 74, except 3 feet off the north side.

Houses will have to be moved on lots 29, 34, 35, 36 and 37, and the right of way of the C. C. C. & I. Railway Company will have to be restricted on part of the line.

We have, after personal examination of the premises, made an assessment of the benefits and damages as follows: The damages from taking the real estate necessary for the proposed widening of said street will amount to \$660.00. The damages from moving houses and other improvements \$660.00. The damages from restricting the car standing room of said Railroad Company are hard to estimate, but we put them at 200.00. Total damages \$1,520.00.

The benefits to property and property owners from opening said street, we estimate at \$800.00.

We think the city of Indianapolis should pay no part of said damages or benefits.

We estimate said damages and benefits in detail, as follows:

Damages to Elizabeth Weileman and her husband, —— Weileman, for a strip 10 feet in width off the north end of lot 30, in Stumph's subdivision of out-lot 44, \$65.00. Damages for improvements, &c., \$10.00. Total damages, \$75.00. Benefits to said Weilemans from opening said street \$60.00. Balance of damages to said Weilemans \$15.00.

Damages to Jno. (f. Stumph for a strip 10 feet wide off the north end of lot 29, in said subdivision, \$60.00. Damages to Stumph from moving frame house on said lot \$125.00. Total damages to Stumph \$185.00. Benefits to Stumph \$65.00. Balance of damages to Stumph \$120.00.

Damages to Henry Miller for a strip 10 feet wide off the south end of lot 34, in said subdivision, \$85 00. Damages to said Miller for moving or cutting off the south end of the frame house on said lot \$100 00. Total damages, \$185 00. Benefits to said Miller on said lot \$75.00. Balance of damages to said Miller \$110.00.

Damages to the Cleveland, Columbus, Cincinnati & Indianapolis Railroad Company for a strip 10 feet wide off the north ends of lots 26, 27, 28, and a strip 10 feet wide off the south ends of lots 35, 36 and 37 in Stumph's subdivision in out-lot 44 (\$50 on each lot), \$300. Damages to said Railroad Company for a strip 10 feet wide off the north side of part of lot 75, and a strip 10 feet wide off the south side of part of lot 74. in ----- subdivision of part of out-lot 44, east of the railroad (\$75 on each strip), \$150. Damages to said Railroad Company for loss of use of car room and tracks as now laid \$200. Damages to said Railroad Company for moving house on lot 35 \$100. Damages to said Railroad Company for moving house on lot 36 \$125. Damages to said Company for moving house on lot 37, all in Stumph's subdivision aforesaid, \$200. Total damages to said Railroad Company from opening said street \$1,075. Benefits to said Railroad Company, on each of lots 26, 27, 28, 35, 36 and 37, of Stumph's subdivision of out lot 44, and on part of lot 75, and part of lot 74 in the Railroad subdivision aforesaid \$75, making in all on said lots \$600. Balance of damages to said Railroad Company from opening said street \$475.

It will thus be seen that the total damages from opening said street are \$1,520. The total benefits \$800. Leaving a balance of damages unprovided

for of \$720. The line of the improvement is so short, and there are so many houses to move, that the benefits are much less than the damages, and the advantages to the city at large are not sufficient to justify us in taxing the city with so great an amount. If we were permitted, however, to tax the benefits which ought to be taxed in Hanna's Addition, this balance could be easily met.

GENTLEMEN:—At the last meeting of your honorable body a proposition was presented from G. W. Hueston and Francis Bergman, proposing to take all the dead animals and other nuisances, &c., from the streets and alleys of the city, &c., provided, however, that you guarantee unto them the exclusive privilege so to do for the term of ten years, and for said services they will not charge the city anything. Now, I would submit to your honorable body that I am at this time doing exactly the work they propose to do, and do not receive, nor ask any remuneration from the city therefor, and, also, without the exclusive privilege they ask for. Such privilege I am free to say I would be glad to have, and if you will give such privilege for the term of ten years I will rgree to do everything they propose to do, and in as acceptable a manner as is possible for such work to be done. I would state further, that I have already been at considerable expense in preparing for the prosecution

of said work, and with the supposition that if I did the work as provided by contract, that I would probably be allowed to continue said business. If I am stopped and the contract let to other parties, I will be thrown out of employment and all the money I have expended in said business would be almost a total loss. I hope your honorable body will give this your consideration, and at least make an investigation into the matter before making any change, and I will ever pray, &c.,

INDIANAPOLIS, August 19, 1872.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:—We, the undersigned citizens of the Eighth Ward and property owners on south East street ask your honorable body to repeal an ordinance, some time since passed. Motion made by Councilman Whitsit for the grading of the first alley east of South East street, running north from

Merrill street through outlot No. 102 to the north-east corner of M. Toole's lot No. 283. The length of this alley is only 264 feet from Merrill street to the corner of Toole's lot, and has never been used by any person as a passway, nor never will be, except by the persons holding the eight lots west of this alley, and they use it only for the purpose of receiving wood at the rear end of our lots on this alley. Gentlemen, we wish you to distinctly understand that this alley lies out in the Commons, on the west side of a large space of vacant ground, owned by Mrs. Downey or Tom Cottrell. There is a sewer just made, running the full length of this alley and is partly filled. As it now is we cannot get wood or anything else from this alley, and if cut down, as proposed, from three to four feet from the bottom of our fencing will forever prevent us from getting wood through it. The cutting down of this alley and removing the earth therefrom will be a great damage, and we look upon it as an outrage. It does the city no good whatever, no persons being interested in the city or out of it but your petitioners and the persons wanting the earth from this alley and high grounds to fill up their low grounds adjoining. We ask your honorable body to have the sewer ditch filled up and the alley not graded, for if cut down it will profit the city nothing, but will be disasterous to your petitioners. If this alley is cut down we positively protest against paying one dollar of the expense for so doing.

Moved, That the City Commissioners locate Fifth street from Illinois to Tennessee street, twenty-four feet wide, immediately south of Wm. Henderson's barn, and to assess benefits and damages.

Moved, That the City Clerk be, and he is hereby, instructed to advertise for proposals for building stone abutments over the Canal on Third street; also, for building an iron superstructure on said abutments—bids to be received separately for such work.

The undersigned respectfully remonstrate against any part of Circle street being converted into a stand for Express Wagons, Hacks, Drays, or similar vehicles.

Circle Park is visited by a large majority of strangers coming to the city, and we earnestly protest against that locality being converted to a use that would make it but little, if any, better than a Livery Stable yard.

Negative-None.

On motion, the Council adjourned.
