REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS,

Monday, August 26, 1872, 7½ o'clock, P. M.

The Common Council met in regular session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Batty, Bollman, Cottrell, Craft, Gibson, Gimber; Hardesty, Kahn, Kennington, Pressly, Reagan, Thalman, Whitsit, Wiles and Woodburn—15.

Absent—Councilmen Bigham, Rush and Sherwood—3.

The proceedings of the regular session, held August 19th, 1872, and of the adjourned session held August 16th, 1872, were read and approved.

Sealed proposals were received, opened, read and referred to the Committee on Contracts.

Mr. Thalman, from the Committee on Contracts, made the following report:

Indianapolis, August 26, 1872.

To the Mayor and Common Council of the City of Indianapolis:

Your Committee on Contracts, to whom was referred sundry proposals for the improvement of streets, have examined the same and would recommend that contracts be awarded as follows:

FIRST.

For grading and graveling the first alley east of Maxwell street, running north and south from Elizabeth to North streets, to James Mahoney, at 27 cents per lineal foot front on each side of the line improved.

SECOND.

For grading and graveling the first alley east of Alabama street, running from Market street to Wabash alley, to James Mahony, at $27\frac{1}{2}$ cents per lineal foot front on each side of the line improved.

THIRD.

For grading and bouldering Sciota alley, running north and south from Washington to Market street, to Patterson & Dunning, at 45 cents per foot front on each side of the line improved.

FOURTH.

For grading and graveling New Jersey street and paving the sidewalks with brick, from St. Mary to Morrison street, there was only one proposal presented, and we, deeming that too high, would recommend that the same be re-advertised.

FIFTH.

For grading and paving with brick the south sidewalk on Pratt street, between Pennsylvania and Delaware streets, to Patterson & Dunning, at 47 cts. per foot front.

SIXTH.

For grading and graveling Greer street and paving with brick the west

sidewalk from Stevens to McCarty street, to Hiram Seibert, at 48 cts. on each side for grading and graveling, and 60 cents per front foot for paving with brick.

SEVENTH.

For grading and paving with brick the south sidewalk on St. Joseph street from Pennsylvania to New Jersey street, to Patterson & Dunning, at 47 cts. per front foot.

EIGHTH.

For grading and paving with brick and curbing with stone the east sidewalk on Alabama street, from Pogue's Run to Louisiana street, to Patterson & Dunning, at \$1 17 for paving, and 57 cents for curbing on the line improved.

NINTH.

For grading and graveling the first alley west of Alabama street, running north and south from South to Merrill street, to John Greene, at 41 cents per lineal foot front on each side of the line improved.

TENTH.

For grading and graveling College avenue and sidewalks, from Home avenue to Tinker street, exclusive of the west sidewalk from Home avenue to Lincoln street, and widening the sidewalks to a width of 18 feet, to Hanway & Hanna at \$1.09 cents from Tinker to Lincoln street on each side of the line improved; and from Lincoln street to Home avenue, excluding the west sidewalk, at \$1.09 cents for the east side, and 89 cents per foot front on the west side.

ELEVENTH.

For curbing with Flat Rock stone the outside edges of the sidewalks on Pennsylvania street, from Washington to North streets, where not already curbed, to Bernard Hamill, at 50 cents per lineal foot front on each side of the line improved.

TWELFTH.

For grading the first alley east of East street, running from Merrill street to the first alley north of Merrill street, to John Greene, at 35 cents on each side of the line improved.

THIRTEENTH.

For grading the alley running from East to Merrill street through out-lot 102, to John Greene, at 15 cents per lineal foot front on each side of the line improved.

FOURTEENTH.

For grading and paving with wooden block pavement Illinois street from the north side of Louisiana to the south side of South street, to John J. Palmer, at \$2.25 cents per square yard.

FIFTEENTH.

For erecting lamp-posts, lamps and fixtures on St. Mary street, from Alabama street to Western avenue, and on Fark avenue, from St. Clair street to Christian avenue, and for the erection of one post at the corner of the alley on the east side of Bellefontaine street, at \$32 for corner and \$31 for intermediate lamps; and on Illinois street, or Westfield Gravel Road, running from Seventh to Morrison street, and on Western avenue from Cherry street to Christian avenue, and on National Road from White River Bridge to Indianapolis, Bloomington and Western Railroad Company's tracks, and on Malotte avenue from Massachusetts avenue to Columbia street, and on Noble street, from Washington to Market street, to D. Root & Co., at \$33 50 for corner, and \$32 for intermediate posts.

SIXTEENTH.

For grading and graveling Fletcher avenue, excluding the sidewalks, from Noble street to Dillon street, we would recommend be re-advertised, with the understanding that the contractor to whom the work is awarded must do the rolling.

Indianapolis, August 26, 1872.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—I have examined Winston street, with reference to the petition of Geo. Brough, Amos Scott, Charles Sobbe and others, which was referred to me by your honorable body.

I find it to be impracticable to carry the water under the Bellefontaine Road, as suggested by the petitioners, but would recommend that the gutters be cleaned out, and that the sidewalks be either paved with brick or regraveled. The body of the street is in good condition but the sidewalks are worn down, and the gutters in many places filled up so that in time of rain the water runs over the adjoining lots.

Indianapolis, August 26, 1872.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—We, the property holders fronting on Rockwood and Louisiana streets, petition your honorable body to have the City Civil Engineer measure the ground between Rockwood and Louisiana streets; also, measure the width of Louisiana street between East and Noble streets, and report the same to the Common Council at their next meeting. The distance between Rockwood and Louisiana streets, as shown on the map, is 133 feet 10 inches, while there is but 123 feet 4 inches by actual measurement. This seems to have considerable to do with the widening of Rockwood street from the north side—the petitioners supposing the map to be correct—and your petitioners will ever pray.

Reference is here given to the City Charter, page 266, of ordinance passed 1852, to have Louislana street widened to a width of 80 feet by the Lawrence-burgh and Upper Mississippi Railroad Company. Furthermore, and that the south line of Louisiana street be established to its full widened width as per widened by said Company, and the same be put upon the city surveys.
