COMMUNICATIONS, ETC., FROM THE MAYOR,

His Honor, the Mayor, submitted the following communication; which was received:

To the Common Council and Board of Aldermen:

Gentlemen:—I have assumed to name Saturday, the 14th inst., as Arbor Day, in this city. Many citizens are interesting themselves in this movement, which, if successful this year, will doubtless result in fixing a day to be hereafter regularly observed, as is now done in many of the Eastern cities.

Garfield and Military Parks can be much beautified and improved by planting additional trees in each of them. A few added each year, would soon make Military Park as attractive as University Square. Of course Garfield Park must be otherwise greatly improved, before it will deserve the name; but this can not be done in the very near future. It takes trees years to mature, however, and the

gradual planting of trees on the parts of the Park now unshaded, will enable the city the more readily to fit it for the uses intended, when the necessary means shall be placed at your command.

in order to aid the general movement to establish Arbor Day, as well as to assist the individual citizens in commencing to beautify our streets and public grounds, I recommend that you place at the disposal of some appropriate committee, the sum of \$300.00, the same, or such portion thereof as they may deem proper, to be used in the purchase and planting of trees in Garfield and Military Parks, on the date above named. I also recommend that steps be taken looking to the *ppointment of a competent person in the near future to take charge of Garfield Park, and repair the fencing, and otherwise guard the property. ALLEN M. FLETCHER, Esq., President Indianapolis Gas Light & Coke Co.:

My Dear Sir: -1 introduced at the last meeting of the Council, a motion requesting your company to furnish gas to private consumers at \$1.25 per thousand cubic feet, pending the negotia ions of the contract between the city and the Gas Company, for the following reasons: In your communication to the Council presented at its last meeting, you say 'in the near future the price of gas to private consumers will be materially reduced." The citizens are now paying \$1.80 per thousand cubic feet, and I believe it is my duty as a Councilman, to look after the interest of the citizens as well as the city, at \$125 per thousand cubic feet, 'I see no prospect in the near future of the Council and Board of Aldermen making a new contract with your company; and believing the citizens should not be compelled to pay \$1.80 per thousand feet for gas until such time as a mutual contract or agreement is reached, I respectfully request that you give the above your immediate and careful con-ideration.
