SPECIAL SESSION—June 15, 1888.

MESSAGES AND PAPERS FROM THE COMMON COUNCIL.

The following message was read:

To the President and Members of the Board of Aldermen:

Gentlemen:—At a meeting of the Common Council in special session, held in the Council Chamber Thursday evening, June 14th, 1888, the action of the Board of Aldermen in adopting the following motion (see page 379, ante)—

"That all bids for electric light be rejected, and that the City Civil Engineer be, and is hereby, directed to advertise for bids for lighting the city with electricity, with not less than six hundred (600) two thousand candle-power arc lights, for a term not exceeding three years; any additional lights to be furnished at a stated price per lamp. The specifications to be modified so as to give the city the first option of purchasing the plant at any time within three years. Bids to be opened at the regular session of the Common Council July 2d, 1888."

The same being a substitute to the motion adopted by the Common Council (see page 358, ante), was non concurred in, and the Council, on motion, adhered to its former action.
