# OPENING AND REFERRING SEALED PROPOSALS FOR PUBLIC IMPROVE-MENTS.

Sealed proposals for the following work were opened, read, and referred to the Committee on Contracts:

To the Mayor and Common Council:

Gentlemen:-A part of your Committee on Contracts make the following report: The circulation of the Gazette is of a limited character, and can in no manner be compared with that of the Sentinel. Business men who advertise in daily papers, expect and do pay more for their advertisements in daily papers than in weekly papers. The Sentinel publishes a sworn statement of its regular circulation, but I have been unable to ascertain, by diligent inquiry, what the circulation of the Gazette is; but I believe that 2,500 would be a liberal estimate, while the circulation of the Sentinel is in excess of twelve thousand daily—consequently being at least five times more than the Gazette, and the Sentinel is therefore much the cheaper bidder, and should be awarded the contract; and I do hereby recommend that the contract be awarded to the Indianapolis Sentinel, at 25 cents per square.

#### COMMUNICATIONS, ETC., FROM THE MAYOR.

His Honor, the Mayor, submitted the following communication; which was received:

#### Indianapolis, Ind., Aug. 6, 1888.

Gentlemen:-Philip H. Sheridan, General of the Army of the United States, died at Nonquitt, Mass., yesterday, after a lingering illness. The flags have already been displayed at half-mast on the City Buildiags, but it seems to me that more

notice than this should be given to this sad event by the city's representatives. General Sheridan was born of very humble parents, and even the place of his birth has never been definitely settled. But whether he first saw the light on this or the other side of the Atlantic, he was every whit an American from the time the public first learned of him. He fought her battles bravely and gloriously. He earned every star he received, and richly deserved the last great honor done him by Congress.

As a slight token of the esteem we bear to his memory, and of the love cherished for him by our fellow citizens who followed him to victory on many of the hardfought fields of the Rebellion, I respectfully suggest the adoption of the memorial and resolutions herewith submitted.

We have heard with deep sorrow of the death of General PHILIP H. SHERIDAN. He was a model soldier and a true patriot. He never thrust himself forward, or courted promotion. The applause of his soldiers over a brave act done or a wise command given, was dearer music to him than the announcement of a new star added to his shoulder from the War Department.

We extend our deepest sympathy to the widow and family of this great soldier and patriotic citizen, and mourn with them the country's loss in his death.

WHEREAS, The Superior Court of Marion County has decided that the Indianap olis Cable Street Railway Company is not a legally incorporated company, and has no lawful corporate existence; And whereas, pretending to act a: a legally incorporated company, its officers and agents are digging up the streets in different parts of the city, and are obstructing the streets by placing its ties and rails therein, to the great damage of the streets and to the injury of the adjoining property, and to the great inconvenience and annoyance of the public, and obstructing public travel on the streets; therefore, be it

*Resolved*, That the Street Commissioner be, and is hereby, directed to notify said company, at once, to stop digging up the streets of the city, or any part thereof, and to immediately remove all ties, rails and other obstructions which they have placed in the streets, or any part thereof, and to put in good condition all the streets or parts of streets which they have dug up. And upon the failure of said company, officers or agents; to comply with such notice at once, the Street Commissioner is hereby authorized and directed to use the necessary force to compel compliance with the same; and the Street Commissioner is further directed to cause such rails, ties and other obstructions, to be removed from the streets, and place said street in a good condition, and collect the costs thereof from said company, officers and agents. And that he report to the Common Council and Board of Aldermen his doings by virue hereof.


