First—With reference to the paying of carpenters in the Street Repair Department, I report that I know nothing of the facts; but Section second of General Ordinance No. 47, 1884, provides, among other things, that the Board of Public Improvements shall have general supervision of the Street Commissioner's Department, and the employment of all laborers and teams, the purchasing of all supplies, etc., and the price to be paid laborers and teams, subject, however, to the order and direction of the Common Council and Board of Aldermen.

Second—As to General Ordinance No. 12, 1888, preventing owners and drivers of vehicles from soliciting trade further than ten feet from the vehicle they own or drive, I see no legal objection to the passage thereof, except that if said ordinance is passed, that the words "The Indianapolis Daily Sentinell" should be stricken

out, and the words "Indianapolis Gazette" substituted.
