The City Civil Engineer submitted the following report; which was referred to the Joint Committee on Finance of the Common Council and Board of Aldermen:

#### To the Mayor, Common Council and Board of Aldermen:

2 Gentlemen: -- I respectfully call your attention to the fact that within the last two years the duties of my office have largely increased, owing to the plans, etc., necessitated in connection with the changes made in the vicinity of the Union Station, an increased amount of general improvements, street paving, bridges, etc., and the introduction of natural gas and electricity.

I also desire to show, that during the time I have served as your Engineer, I have performed the duties without the assistance of an Assistant Engineer, and without any increase of the regular force in the office, except during the putting in of natural gas; the latter item alone has fully doubled the work and responsibilities of my department.

I also represent to you, that the salary of the Civil Engineer in this city, together with the total expenses of maintaining the department, is less than half that of other cities similarly situated.

Therefore, I most respectfully ask that you fix my salary at three thousand dollars (\$3,000) per annum, from the first of next January. I submit herewith, for comparison, a table showing the Civil Engineer's salary, the number of assistants, and the expenses of the departments, in nine other cities. Respectfully submitted,

The City Civil Engineer submitted the following report; which was read:

To the Mayor, Common Council and Board of Aldermen:

Gentlemen:-Deeming it for the best interest of the City, to promote cleanliness, and to prevent the unsightly obstruction to Washington, and other streets now, or a general ordinance, prohibiting the standing of public vehicles on any street so paved, and, as in my opinion there is an emergency for the taking effect of this ordinance, I recommend its speedy passage.

I also call your attention to the necessity of the adoption of some system of cleaning Washington, and the asphalt paved streets around the new Union Passenger Station.

Washington street particularly, is now in a filthy condition, owing to the lack of thorough sweeping. I am informed by the Street Commissioner that the machine he now has for that purpose is practically worthless.

As one of the advantages of asphalt pavement is in its cleanliness, I would recommmend as a means contributing to cleanliness, that merchants and others doing business upon Washington street, and other asphalt paved streets, be prevented from sweeping papers, dirt, etc., upon the street, and to that end I recommend that the Superintentent of Police be instructed to strictly enforce the provisions of section 32 of the ordinance upon the subject, passed September 2.  $187^{4}$ , and that the City purchase a street sweeper of sufficient capacity to thoroughly sweep all asphalt streets now laid, and that the Street Commissioner be instructed to sweep all of said streets every night after midnight, and to remove said sweepings before

The Street Commissioner submitted the following report:

To the Mayor, Common Council and Board of Aldermen of the City of Indianapolis:

Gentlemen :-- Persuant to your instructions I hereby report the cost of street sweeping machines, as follows :

Barnard Castle three-wheeled, six-foot machine, on board the cars, in New York City, \$300.

Same, four-wheeled, seven and one-half foot machine, on board the cars, in New York City, \$400.

Extra set of brooms, for small machine, \$30.

Extra set of brooms, for large machine, \$40. as in use in Washington, Chicago, Louisville, St Louis, Omaha and Columbus, Ohio, with a broom five feet in diameter and twelve feet long, guaranteed to sweep 200,000 yards nightly, \$1,000.

The Barnard Castle machines are small and very similar to the one now owned by the city.

In purchasing a machine the city should obtain one large enough to sweep more street than can be done with the small machine; therefore I recommend the purchase of the Capitol machine.

## REPORTS, ETC., FROM OFFICIAL BOARDS.

The following communication from the Board of Health, was read and referred to the Judiciary Committee and City Attorney :

To the Mayor, the Board of Aldermen, and the Common Council of the City of Indianapolis:

Gentlemen:—The following resolution was approved and adopted by the Indianapolis Board of Health in regular session, Dec. 1, 1888:

Resolved, That it be the sense of the Board of Health of the City of Indianapolis, Ind., that the three vaults located in Greenlawn Cemetery in this city, and are owned or are under the control of C. E. Kregelo, Renihan, Long & Hedges, and C. Girton respectfully, have become and are nuisance by reason of the stench and noxious odors arising from the decayed bodies resting therein, and the constant danger of the spread of disease from this source.

And be it further resolved, That said vaults be and the same are declared nuisance, and that the same be abated.

And be it further ordered, That each of said owners of said vaults, shall within thirty days from the passage of this resolution, remove from their vaults all of the bodies resting therein and bury the same. And that in case of failure to comply with the provisions of this resolution, prosecutions against said owners of the vaults, or the claimant of the bodies, or both, will be instituted. And that the secretary of this Board be instructed to prepare and serve upon each of said owners a copy of this resolution.

WHEREAS, At the sale of stalls at the East Market Hous, in May last, one Themas David bid in, paid for, and took possession of stall No. 50, in said Market House. About five weeks ago said David died. After his death, Mrs. David, his widow, attempted to sell her right in the lease of said stall to one Theodore Dietz. On December 1, Mr. Dietz went to the City Clerk's office and tendered the quarterly rent at the rate of \$8000 per annum, the price to have been paid by Mr. David. On tendering the money, he was notified by the City Clerk, that said stall had been sold by the Market Master to one Lewis Roos, \*t a rental of \$45.00 per annum, such sale having been made without the knowledge of the heirs of said David.

Whereas, Such action, on the part of the Market Master, is in direct conflict with the rights of said heirs, under said lease, and the reduction of rent is against the best interests of the City; therefore,

Be it Resolved, That the City Clerk be, and he is hereby directed to refund to said Roos, the money paid by him as rental for said stall, and receive and receipt for the rent of said stall from the heirs of said Thomas David, aforesaid at the quarterly rent of \$20,00, which was to have been paid by said David, deceased.

Gentlemen: — We, the undersigned, citizens of the seventeenth and eighteenth Wards, and the merchants in the immediate vicintty of Maryland and Delaware streets and Virginia avenue, respectfully petition your honorable body to order a stone foot crossing beginning at the intersection of the northwest corner of Maryland street and Virginia avenue, thence across Virginia avenue to the northwest corner of Delaware street and Virginia avenue.

C. B. Denning, G. Hafacker, Z Mascar, G. W. Dick, C. H. Abbott--and eighty-three others.

Moved, That the Street Commissioner be directed to put a double stone crossing beginning at the intersection of the northwest corner of Maryland street and Virginia avenue; thence across Virginia avenue to the northwest corner of Delaware street and Virginia avenue.

Councilman Hicklin offered the following motion:

To reconsider the vote by which the asphalt ordinances, Nos. 84, 85 and 86 of 1888, passed this body at its last session.

Councilman Thalman demanded the previous question.

The main question was then put, and the motion offered by Councilman Hicklin adopted by the following vote:

Ares, 21-viz: Councilmen Burns, Cummings, Davis, Dunn, Elliott, Finch, Gasper, Hicklin, Johnston, Kelly, Long, Markey, McClelland, O'Connor, Parkinson, Pearson, Smith, Stuckmeyer, Thalman, Trusler, and Wilson.

Councilman Johnston offered the following motion; which was adopted :

That the Street Commissioner order the J. M. & I. Railroad Company to open and clean out the gutter on the east side of Chestnut street, from Morris street to Madison avenue. Now, if the work is not done within ten days after the Street Commissioner has served such notice, then the Street Commissioner shall do the work and charge the same to the company. Councilman Johnston offered the following motion; which was referred to the Board of Public Improvements:

That the Street Commissioner be directed to lay a sewer pipe in the third alley north of Ray street, from Locust street to Union street, there to connect with the sewer in Union street. The said sewer pipe is to be large enough to carry all the water that may accumulate in Locust street.

Councilman Kelly offered the following motion; which was referred to the Committee on Public Light:

That the City Clerk be directed to notify the Gas Company to remantle the gas-post at the mouth of the first allev north of Bicking street, on Southeast street. That two vapor lights be erected on Valley street.

Councilman McClelland presented the following petition; which was referred to the Committee on Streets and Alleys, City Civil Engineer and City Attorney, and that the Street Commissioner be not allowed to remove said fence without further notice:

#### Indianapolis, November 30th, 1888.

To His Honorable Mayor, and Members of the Common Council:

Gentlemen:—The undersigned, your petitioners, respectfully represent to you honorable body:

That we are the owners of lots 65 and 66 in Noble subdivision of the western part of Out-lots 45, 50, 55, 56 and 61, in this city, a plat of which is recorded in Platt Book No. 1, page 31.

That we have this day been notified by the Street Commissioner to remove the fence enclosing our property, from "Walnut street," within five days. And upon our failure to comply, that the Street Commissioner remove the same at our expense, etc., in pursuance of a resolution passed by your honorable body on the 13th instant.

Your petitioners cannot believe that your honorable body has any desire or intention to take our private property for a public highway without due process of law, and without proper compensation therefor.

But we believe that your honorable body has been imposed upon, by relying upon the misrepresentation of interested and designing men. And that you have acted without proper prior investigation, neglecting the wise saying, "First know that you are right, and then go ahead."

For the better information of your honorable body, we respectfully submit to you, and make it a part of this petition, a true and correct plat, copied from the records of the county, of all the property, including our own, between St. Clair on the north, and North street on the south, and Noble street on the west, and Railroad street on the east.

The plat aforesaid will show your honorable body the following facts, to wit:

1. That the first street south of St. Clair is North street,

2. That no "Walnut street" exists alongside of our property, which we could illegally enclose in a fence.

3. That Walnut street ends on the west side of Noble street, 330 feet south of a point 245 feet west of our property.

4. That not only no Walnut street exists alongside of our property, but also that no other legal public highway, deserving the name of a street, exists there.

5. That the only legal public highway, that exists alongside of our property, is a fifteen feet alley, donated to public use by James Gill(spie; as for his plat and subdivision of Out-lot 43, recorded in Plat Book No. 1, page 13.

6. That although the size of lots 64 and 65 in Noble subdivision aforesaid, are not stated on the recorded plat in feet and inches, but the plat plainly shows those lots to be much larger than the lots south of them, which are marked forty feet front.

7. That the plat aforesaid plainly shows that the north line of said lots 64 and 65 is the north line of Out-lot 45, and bordering on the fifteen feet wide alley aforesaid, on the south side of Out-lot 43.

And your petitioners can verify to your honorable body, that in purchasing lots 65 and 66 from John L. Ketcham, commissioner, etc., we paid a proportionately higher price for lot 65 than we did for lot 66, for the reason aforesaid, "that it was a larger lot."

Your petitioners admit that, partly in ignorance of or indifference to our rights in the premises, we have for some time permitted the public to trespass upon our property. But lately we have had the same surveyed by a competent civil engineer, who, after examination of the public records, gave us the true boundaries of our lots. And thereafter we enclosed the same in a fence, and nothing more.

Your petitioners would therefore respectfully ask your honorable body to reconsider your hasty and ill-advised action in the premises, and refer the same to a proper committee, with the city attorney, or the mayor, or both, for proper investigation and verification of the facts herein set forth. And we will ever pray, &c.

Councilman O'Connor offered the following motion; which was referred to the Committee on Puplic Light:

That the City Civil Engineer be and is hereby instructed to direct the Sun Vapor Light Company to erect four (4) street lamps on Cruse street, from Washington street to the C. I. St. L. & C. R. R tracks, also to erect four (4) street lamps on Michigan avenue from Washington street to Oriental street.

Councilman O'Connor offered the following motion; which was adopted:

That the Cincinnati, Indianapolis & St. Louis Railroad Company are hereby ordered and directed to palnk the crossing of their track on the first alley south of Bates street between Dillon and Leota streets, and that the City Clerk be directed to notify said company of the passage of this motion.

Councilman Parkinson offered the following motions; which were referred to the Board of Public Improvements:

That the Street Commissioner be instructed to clean the gutters on South street from Illinois street to Missouri street.

That the Street Commissioner be and is hereby ordered to clean the gutters on Mississippi street from Washington street to Merrill street.

Councilman Smith offered the following motion; which was referred to the City Civil Engineer:

That the City Engineer be ordered to arrange to have the crossings and gutters at corner of Delaware and Walnut streets. raised to a proper heighth, and to correspond with the street.

Councilman Stuckmeyer offered the following motion; which was adopted:

That E. E. Jackson be granted the right to curb and bowlder the gutter, and widen the sidewalk in front of his premises on south Pine street, at his own expense, and under the direction of the City Civil Engineer.

Councilman Stuckmeyer offered the following resolution; which was referred to the Committee on Railroads:

Resolved by the Common Council and Board of Aldermen of the City of Indianapolis, That the Citizens' Street Railway Company be and it hereby is ordered to run its cars on the English avenue and Irvinton line not farther apart than one car every fifteen (15) minutes, said cars to run out as far as the east city limits on this schedule, and to begin running at six o'clock a. m., and run until ten o'clock p. m., of every day, except Sundays. This schedule shall go into effect within ten (10) days from the service on said company of a certified copy of this resolution.

The City Clerk is hereby ordered to prepare and serve on said company a certified copy of this resolution.

Councilman Thalman offered the following motion; which was adopted:

That the City Clerk be directed to hereafter embody no claim or account in the Appropriation ordinance, unless the same has been approved by the board or committee under whose head the same has been contracted. Also that the City Attorney be added to the committee on Accounts and Claims.

Councilman Thalman presented the following petition; which was referred to the Committee on Public Chairty.

To the Honorable Mayor and Members of the Council of the City of Indianapolis:

In the name of the Association which has for its sole object the care of the sick poor of this City, we respectfully and earnestly ask you to consider our appeal.

We solicit from the public but once a year through our Annual Fair; three of these have been held in Tomlinson Hall. Last year we paid sixty dollars for the use of the hall for one week. Soon after, the Catholics secured the hall for the same length of time, without charge. If, under the present regulations the same generosity cannot be made to our Association, we hope that a liberal reduction may be secured by your allowing the bill to cover only the actual expenses for one week. That the City Attorney and Committee on Judiciary be requested to investigate as to the responsibility of the City to furnish ground for pauper burials, and whether or not the County Commissioners are not r quired to furnish a place for such burials. If the responsibility rests with the City that they report what provision can be made, and where and at what price such ground can be obtained.

Councilman Trusler offered the following motions; which were referred to the Committee on Streets and Alleys:

That the Street Commissioner be instructed to take immediate steps to drain the first alley south of Woodlawn avenue, between Spruce and Reid street.

That the Street Commissioner be instructed to repair with broken stone the crossing of Prospect and Linden streets, and the crossing of Prospect and Spruce streets.

Councilman Trusler offered the following resolution; which was referred to the Committee on Water:

*Resolved*, That the Indianapolis Water Company be, and is hereby directed, to extend its mains on Fletcher avenue to Reid street, and on Reid street to Pittsburgh, Cincinnati & St. Louis Railroad track, and to locate five hydrants as per contract, under the direction of the Chief Fire Engineer, including one fire hydrant opposite Asylum for the Deaf and Dumb.

On motion the Common Council then adjourned at 12.45 A. M.
