To the Mayor and Common Council:

Gentlemen:--Your Committee on Finance respectfully report that there will be due, on January 1st, 1889, seventy thousand dollars (\$70,000), temporary loan, made one year ago, and would recommend that the Mayor and Committees on Finance of the Common Council and Board of Aldermen be authorized to make a temporary loan of one hundred thousand dollars (\$100,000,) and to take up said seventy thousand dollars (\$70,000), temporary loan; said loans to be on the most favorable terms obtainable, and recommend the adoption of the accompanying resolution.

Resolved, That the Citizens Street Railway Company be, and it is hereby ordered, to take up and remove the turn-table owned and used by it on Illinois street, near Tenth street, within fifteen days from the passage of this resolution, and to run its cars on Illinois street north to Twelfth street.

The City Clerk is hereby ordered to prepare and serve on said company a certified copy of this resolution.

The following motions (see pages 813, 815, 816 and 817, ante), were read, and concurrently adopted:

That the Street Commissioner order the J. M. & I. Railroad Company to open and clean out the gutter on the east side of Chestnut street, from Morris street to Madison avenue. Now, if the work is not done within ten days after the Street Commissioner has served such notice, then the Street Commissioner shall do the work and charge the same to the company.

That the Cincinnati, Indianapolis & St. Louis Railroad Company are hereby ordered and directed to palnk the crossing of their track on the first alley south of Bates street between Dillon and Leota streets, and that the City Clerk be directed to notify said company of the passage of this motion.

That E. E. Jackson be granted the right to curb and bowlder the gutter, and widen the sidewalk in front of his premises on south Pine street, at his own expense, and under the direction of the City Civil Engineer.

That the City Clerk be directed to hereafter embody no claim or account in the Appropriation ordinance, unless the same has been approved by the board or committee under whose head the same has been contracted. Also that the City Attorney be added to the committee on Accounts and Claims.

That the City Attorney and Committee on Judiciary be requested to investigate as to the responsibility of the City to furnish ground for pauper burials, and whether or not the County Commissioners are not required to furnish a place for such burials. If the responsibility rests with the City that they report what provision can be made, and where and at what price such ground can be obtained.

The following message was read;

Gentlemen:—I herewith inform your honorable body that at a regular session of the Common Council held December 3d, 1888, the following motion was adopted, viz:

Second—We would be compelled to pay city taxes, for which, for a long time, we would receive no return, as we would not get fire and police protection.

Third—It would put the City of Indianapolis to a large expense in furnishing fire protection and maintain a Police force, and water and gas supplies.

Resolved, further, That the City Clerk be, and he is hereby, directed to file a certified copy of the foregoing preamble and resolution, and the action of the Common Council and Board of Aldermen thereon, in the office of the Recorder of said county, who is authorized and directed to record the same.

Which motion to non-concur failed of adoption, by the following vote:

AYES, 4-viz: Aldermen Clark, Laut, Rail, and Reinecke.

NAYS, 5-viz: Aldermen Reynolds, Smith, Taylor, Tousey, and President Wright.

Alderman Taylor moved that further consideration of said resolution be postponed until the next regular meeting.

Which motion was adopted, by the following vote:

Ayes, 5-viz: Aldermen Reynolds, Smith, Taylor, Tousey, and President Wright. NAYS, 4-viz: Aldermen Clark, Laut, Rail, and Reinecke.

President Wright introduced the following entitled ordinance, which was read the first time:

G. O. 56, 1888—An ordinance donating the use of Tomlinson Hall to Francis Murphy for the evenings of the week commencing Sunday, December 16th, 1888.

President Wright moved that the Rules be suspended for the purpose of placing the foregoing entitled ordinance—G. O. 56, 1888—on its final passage.

Which motion failed of adoption, by the following vote:

AYES, 3-viz: Aldermen Clark, Rail, and President Wright. NAYS, 6-viz: Aldermen Laut, Reinecke, Reynolds, Smith, Taylor, and Tousey.
